WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **One Hundred Thirty Five Thousand and 00/100 Dollars (\$135,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Emily D. Dickinson an unmarried person

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Todd B. Seales and Jessica H. Seales

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

Lot 13, Block 1, and all that part of the North Half of the Southeast Quarter of Section 21, Township 22, Range 3 West that lies North of Lot 13, Block 1, according to Arden's Subdivision of the town of Montevallo, Alabama according to Map as filed in the Probate Office of Shelby County, Alabama in Map Book 3, Page 64.

\$132,554.00 of the proceeds come from a mortgage recorded simultaneously herewith.

\$amount of the proceeds come from a second mortgage recorded simultaneously herewith.

Subject to: (1) 2017 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantor; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

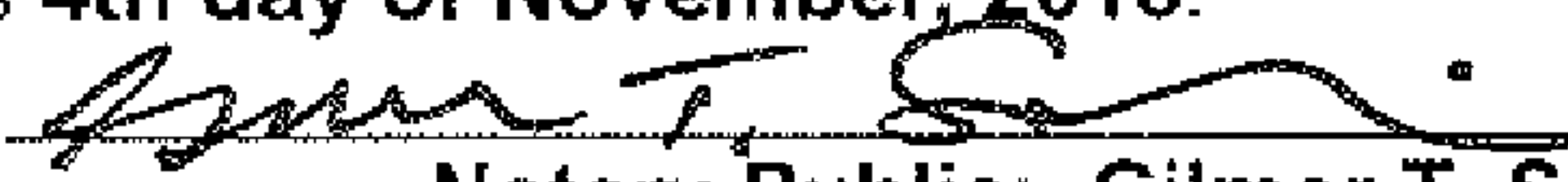

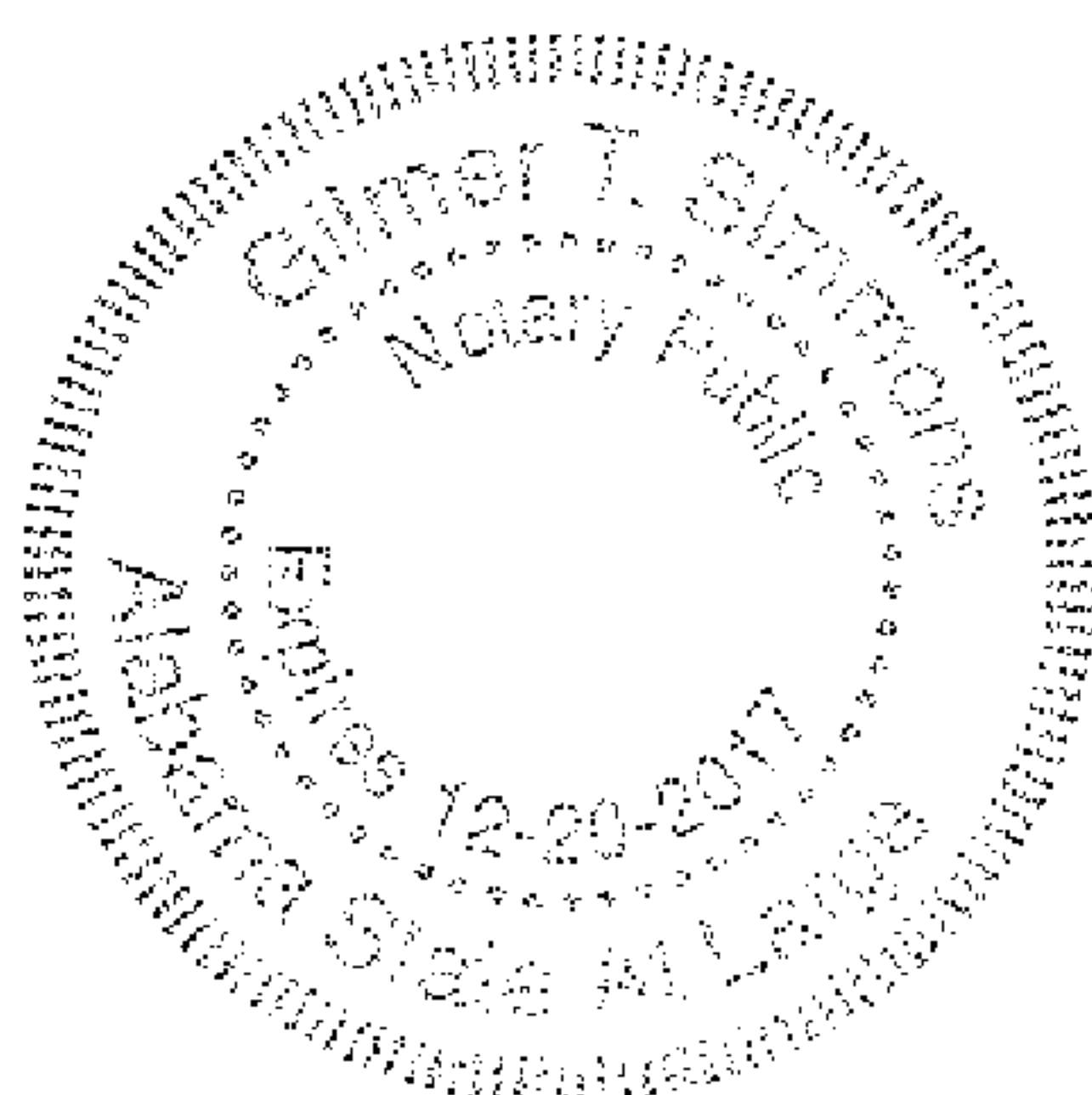
