## CONVEYANCE OF RIGHT OF WAY EASEMENT

This Agreement, made this the day of November, 2016, by and between HIGH TIMES ADVVENTURE REAL ESTATE CO., LLC (hereinafter "Grantor") and TRI-L ACRES AIRPARK, LLC, and Alabama Limited Liability Company (hereinafter "Grantee"):

## WITNESSETH:

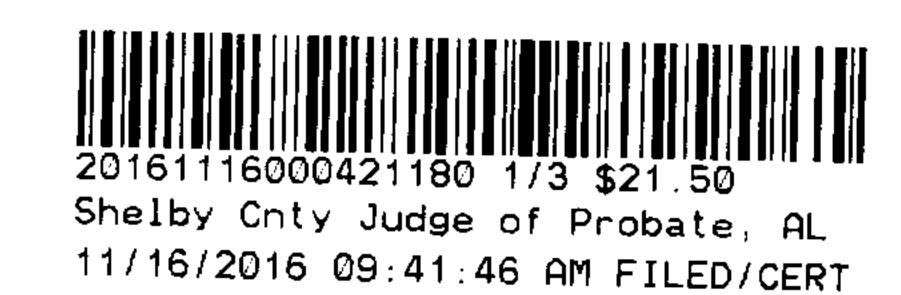
Whereas, the Grantor has heretofore conveyed to the Grantee certain land for the construction and maintenance of a grass runway over certain lands owned by the Grantor; and

Parcel 1: Commence at a railroad rail in place accepted as the Northeast corner of the Southeast one-fourth of the Southwest one-fourth of Section 36, Township 20 South, Range 1 West, Shelby County, Alabama; thence proceed South 88° 47′ 14″ West along the North boundary of said quarter-quarter Section for a distance of 1120.10 feet to the point of beginning. From this beginning point proceed South 44° 21′ 44″ West for a distance of 808.41 feet; thence proceed North 45° 38′ 16″ West for a distance of 30.00 feet; thence proceed North 44° 21′ 44″ East



for a distance of 777.80 feet; thence proceed North 88° 47' 14" East for a distance of 42.86 feet to the point of beginning.

The above described land is located in the Southeast one-fourth of the Southwest one-fourth and the Southwest one-fourth of the Southwest one-fourth of Section 36, Township 20 South, Range 1 West, Shelby County, Alabama and contains 0.55 acres.

Parcel 2: Commence at a railroad rail in place accepted as the Northeast corner of the Southeast one-fourth of the Southwest one-fourth of Section 36, Township 20 South, Range 1 West, Shelby County, Alabama; thence proceed South 88° 47′ 14″ West along the North boundary of said quarter-quarter Section for a distance of 1120.10 feet; thence continue South 88° 47′ 14″ West for a distance of 128.58 feet to the point of beginning. From this beginning point South 44° 21′ 44″ West for a distance of 716.58 feet; thence proceed North 45° 38′ 16″ West for a distance of 30.0 feet; thence proceed North 44° 21′ 44″ East for a distance of 685.97 feet; thence proceed North 88° 47′ 14″ East for a distance of 42.86 feet to the point of beginning.

The above described land is located in the Southeast one-fourth of the Southwest one-fourth and the Southwest one-fourth of the Southwest one-fourth of Section 36, Township 20 South, Range 1 West, Shelby County, Alabama and contains 0.48 acres
