

ARTICLES OF ORGANIZATION

OF

AVX LIMITED, LLC

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, Ken Martin, acting as the sole member of a limited liability company under the laws of Alabama, hereby adopts the following Articles of Organization for AVX Limited LLC (hereinafter referred to as "the Company"):

ARTICLE I

NAME OF COMPANY

The name of the Company shall be AVX Limited, LLC.

ARTICLE II

PERIOD OF DURATION

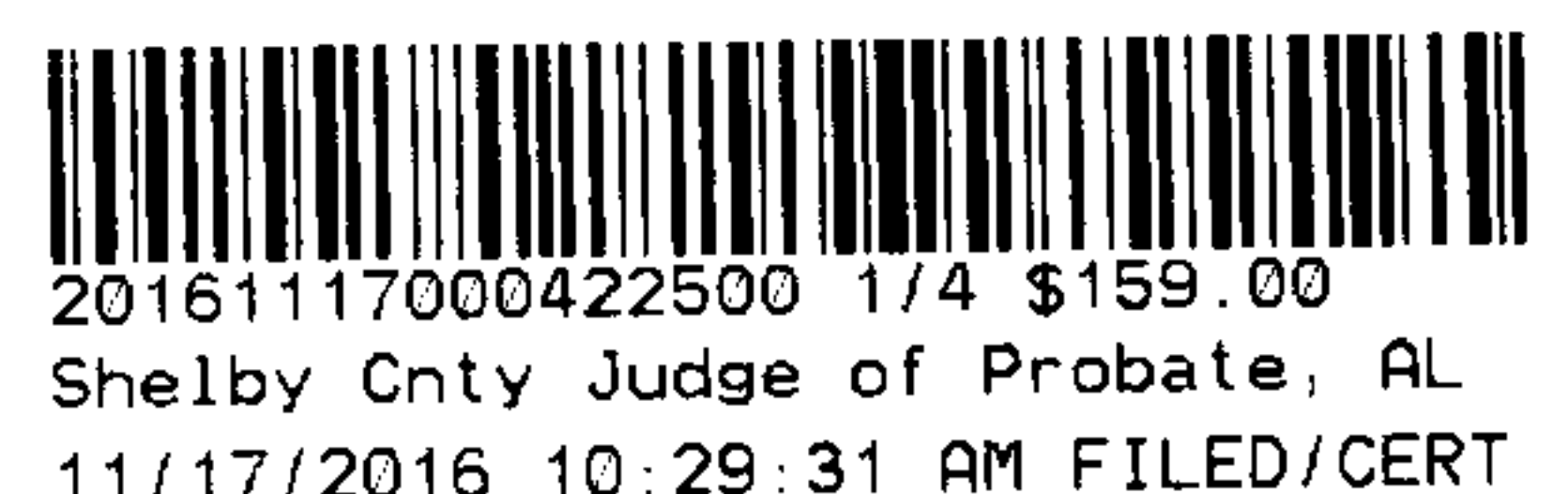
Unless the Company is earlier dissolved under Article VII of these Articles of Organization or the Alabama Limited Liability Company Act, the period for the duration the Company shall be perpetual.

ARTICLE III

OBJECTS AND PURPOSES

The objects and purposes for which the Company is organized are:

1. To provide consulting services.
2. To transact any and all lawful business for which companies may be organized under the Alabama Limited Liability Company Act, as such Act may be amended from time to time.
3. To have and to exercise all powers necessary or convenient to effect the above purposes.



The foregoing paragraphs of this Article III, and each phrase thereof, shall be construed,

in their broadest sense, as purposes and powers of the Company in addition to those powers

specifically conferred upon the Company by law, and it is hereby expressly provided that the

foregoing specific enumeration of purposes and powers shall not be held to limit or restrict in

any manner the powers of the corporation otherwise granted by law. Nothing herein

contained, however, shall be construed as authorizing this Company to carry on the business

of banking or that of a trust company, or the business of insurance.

ARTICLE IV

REGISTERED OFFICE AND INITIAL REGISTERED AGENT

The location and mailing address of the initial registered office of the Company in the State of Alabama shall be 535 Dogwood Circle, AL 35244, and the corporation's initial registered agent at such address shall Ken Martin.

ARTICLE V

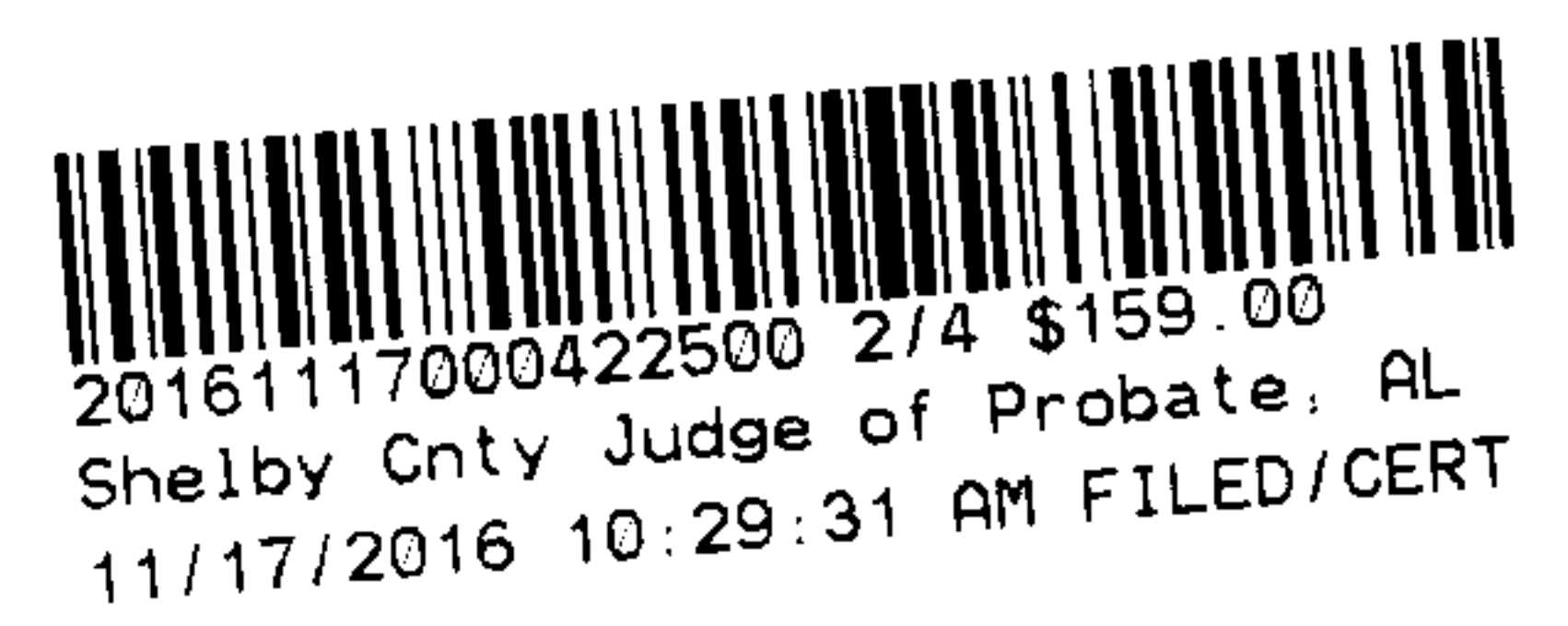

The Company may admit additional members upon such terms and conditions as may be specified by the existing members upon the unanimous written consent of the existing members.

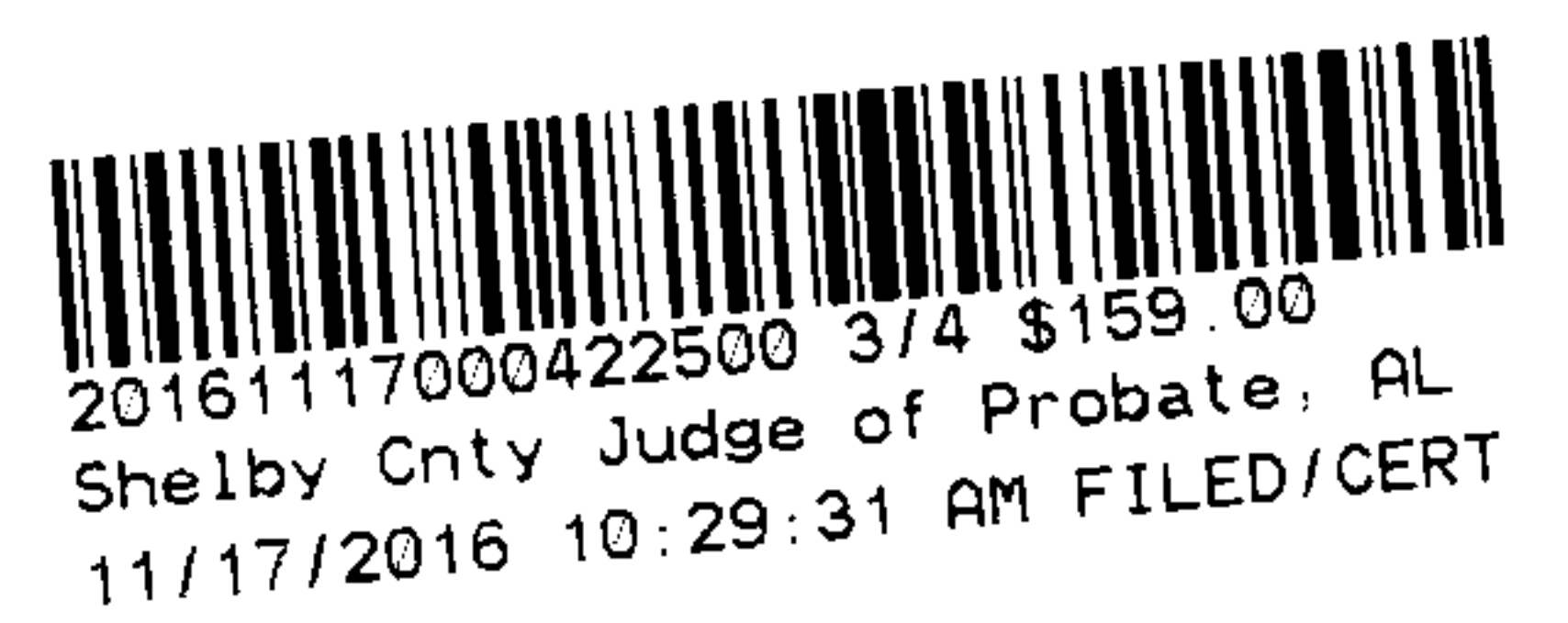
ARTICLE IX
