## FORECLOSURE DEED

## KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, 12/30/2004, Constance G. 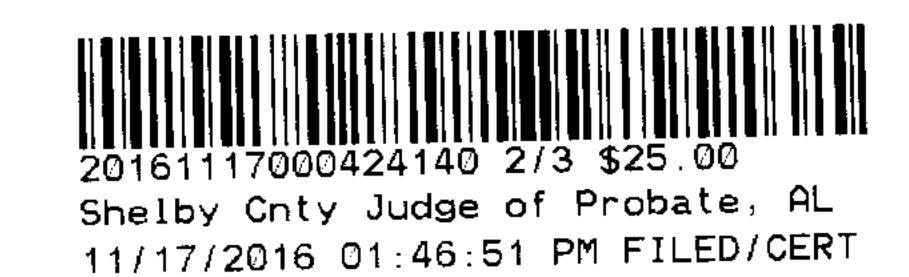
