

EXHIBIT A

A part of Lot 7 Oak Mountain Commerce Place as recorded in Map Book 18, Page 58 in the Office of the Judge of Probate in Shelby County, Alabama. Being located in the NW 1/4 of Section 6, Township 20 South, Range 2 West, more particularly described as follows: Commence at the NE corner of Section 1, Township 19 South, Range 3 West, said point also being the NW corner of Section 6, Township 20 South, Range 2 West and lying on the westerly line of said Lot 7; thence in a southerly direction along the westerly line of said Lot 7 and said Section 6, a distance of 773.15 feet to the point of beginning; thence continue along last described course a distance of 503.15 feet to the northerly right of way line of Green Park Road; thence 90 degrees 50 minutes left in an easterly direction along said right of way line a distance of 55.68 feet to the beginning of a curve to the left having a central angle of 73 degrees 32 minutes 00 seconds and a radius of 94.93 feet; thence in a northerly direction along arc of said curve and right of way line a distance of 121.83 feet to end of said curve and the beginning of a curve to the right having a central angle of 23 degrees 18 minutes 00 seconds and a radius of 267.51 feet; thence in a northerly direction along said curve and right of way line a distance of 108.79 feet to end of said curve; thence in a northeasterly direction along said right of line a distance of 302.0 feet; thence 73 degrees 56 minutes 57 seconds left in a northwesterly direction a distance of 278.31 feet to a point on the southerly right of way line of Commerce Court, said point being on a curve having a central angle of 84 degrees 42 minutes 08 seconds and a radius of 50.0 feet; last described course being radial to said curve; thence in a westerly direction along said right of way line and along arc of said curve to the right a distance of 73.92 feet; thence in a southwesterly direction along a line radial to said curve a distance of 207.87 feet to the point of beginning; being situated in Shelby County, Alabama.
