KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of April, 2015, Anita McReath, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for DHI Mortgage Company, LTD., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20150604000184790, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC, by instrument recorded in Instr 20160928000355660, in the aforesaid Probate Office ("Transferee"); and

offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

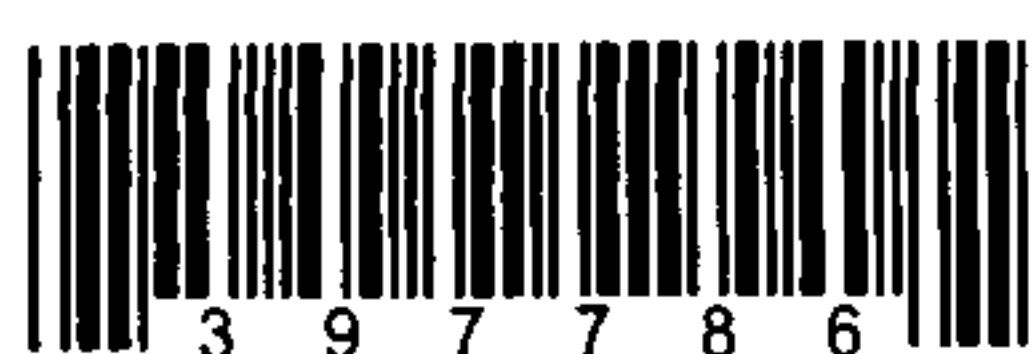

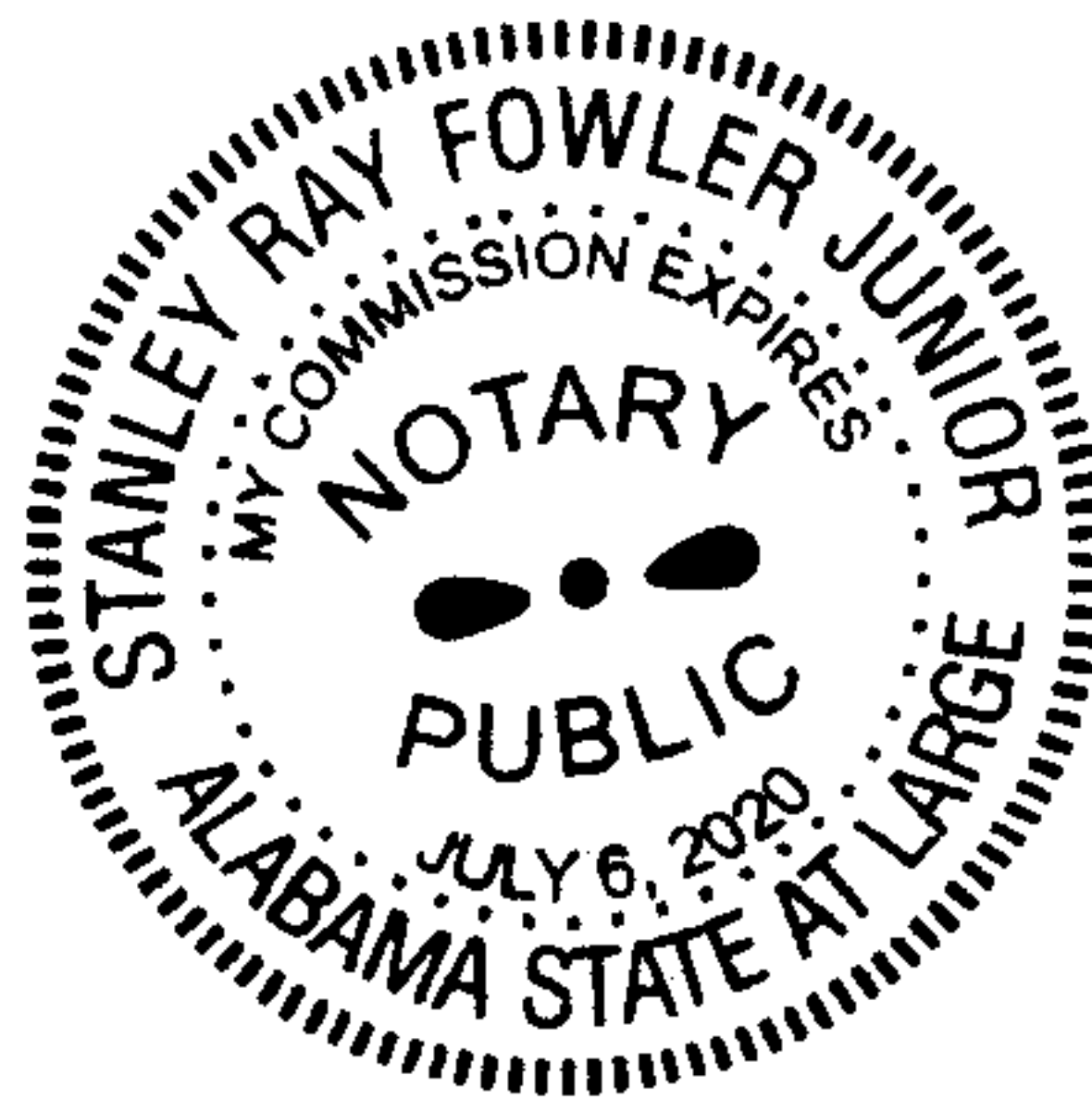
