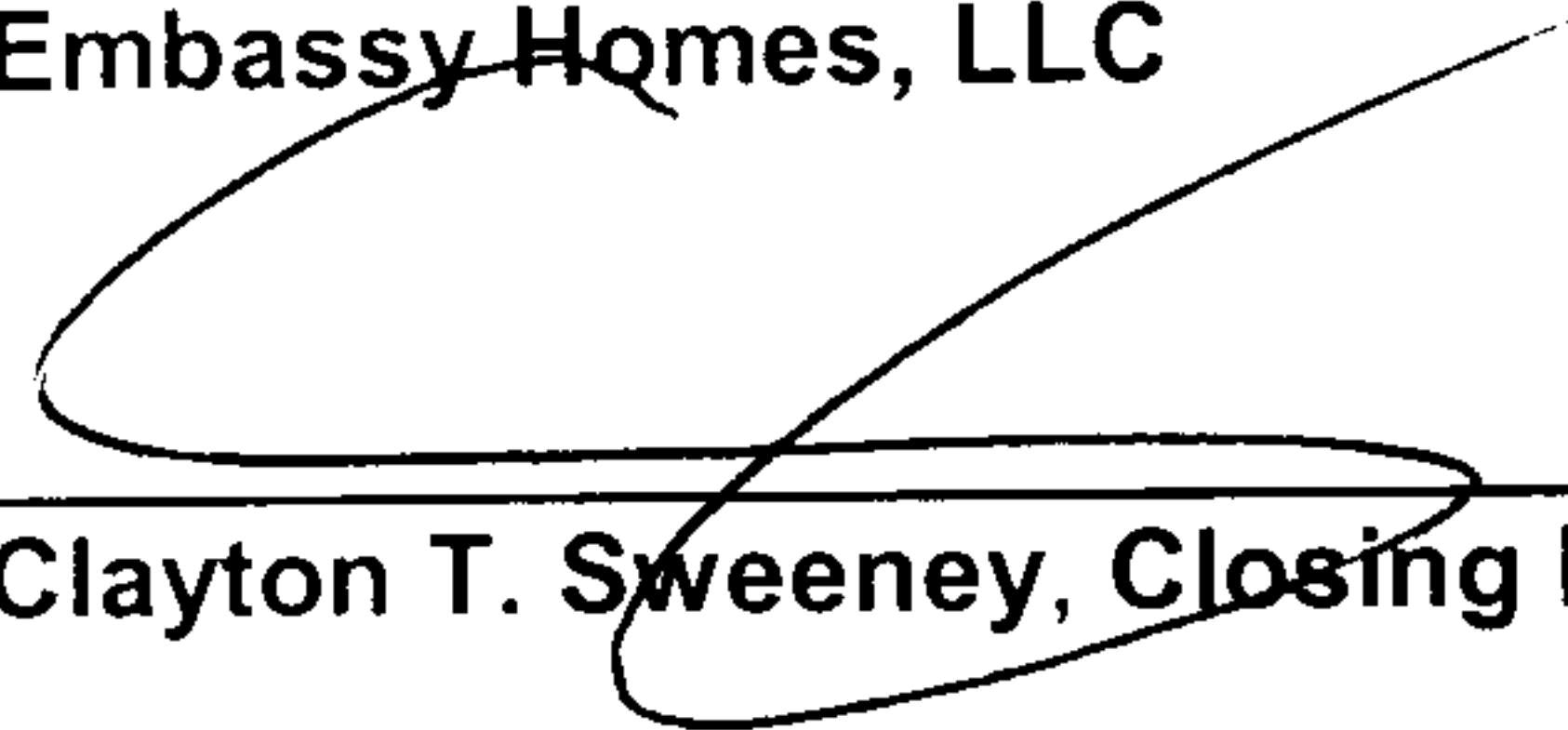
This instrument is executed as required by the Articles of organization and operational agreement of said limited liability company and same have not been modified or amended.

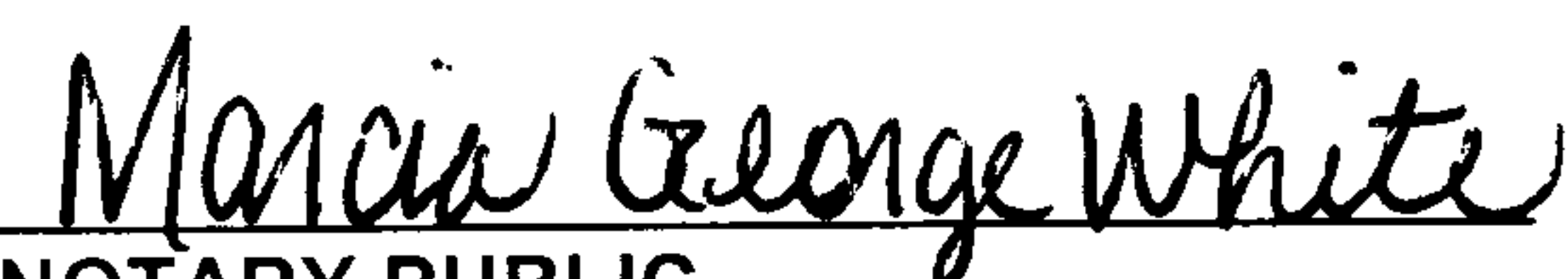

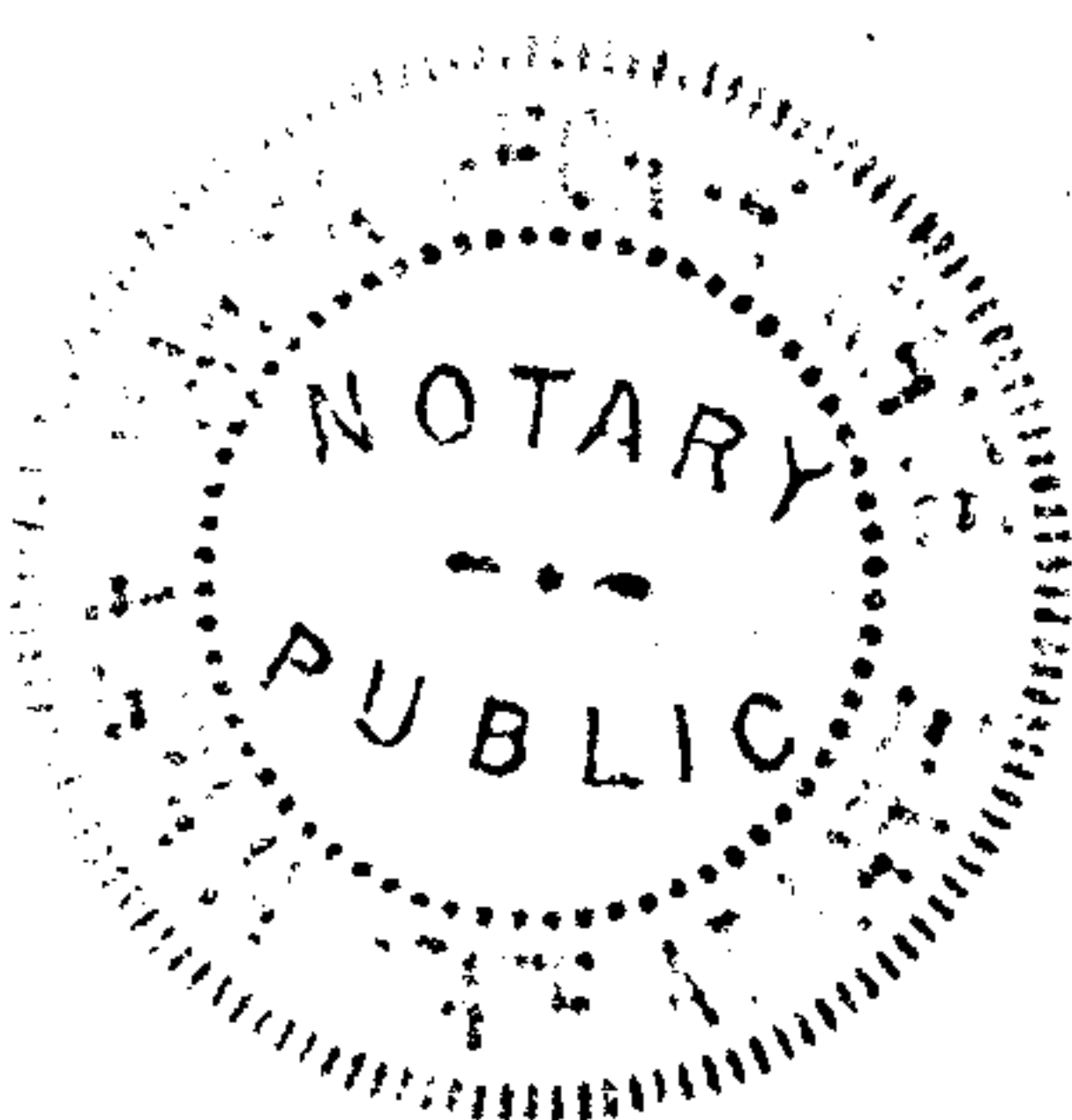
