## **Subordination Agreement**

THIS AGREEMENT is made and entered into on this 27th day of October, 2016, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of Regions Bank dba Regions Mortgage, its successors and/or assigns (hereinafter referred to as "Lender").

## RECITALS

Regions Bank loaned to Amy K Williams (the "Borrower", whether one or more) the sum of \$16,000.00. 
