\$156,001.00 of the consideration was paid from the proceeds of a mortgage loan

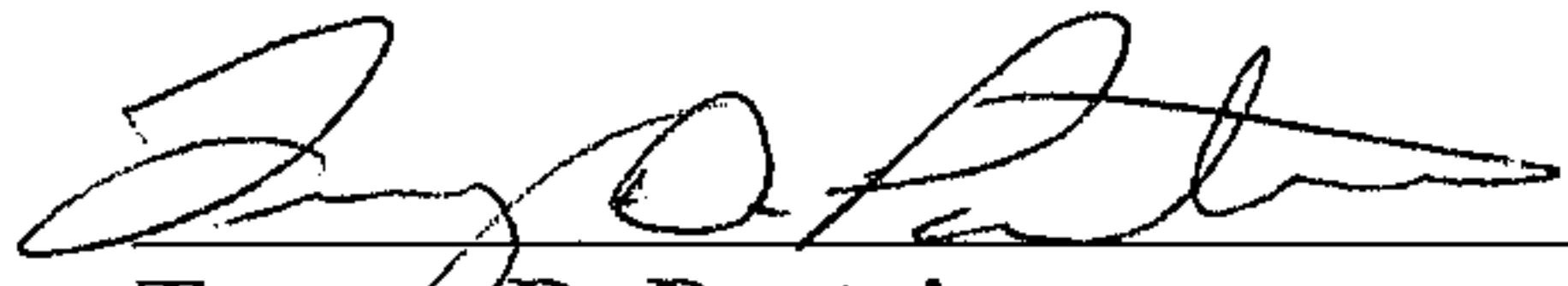
Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.

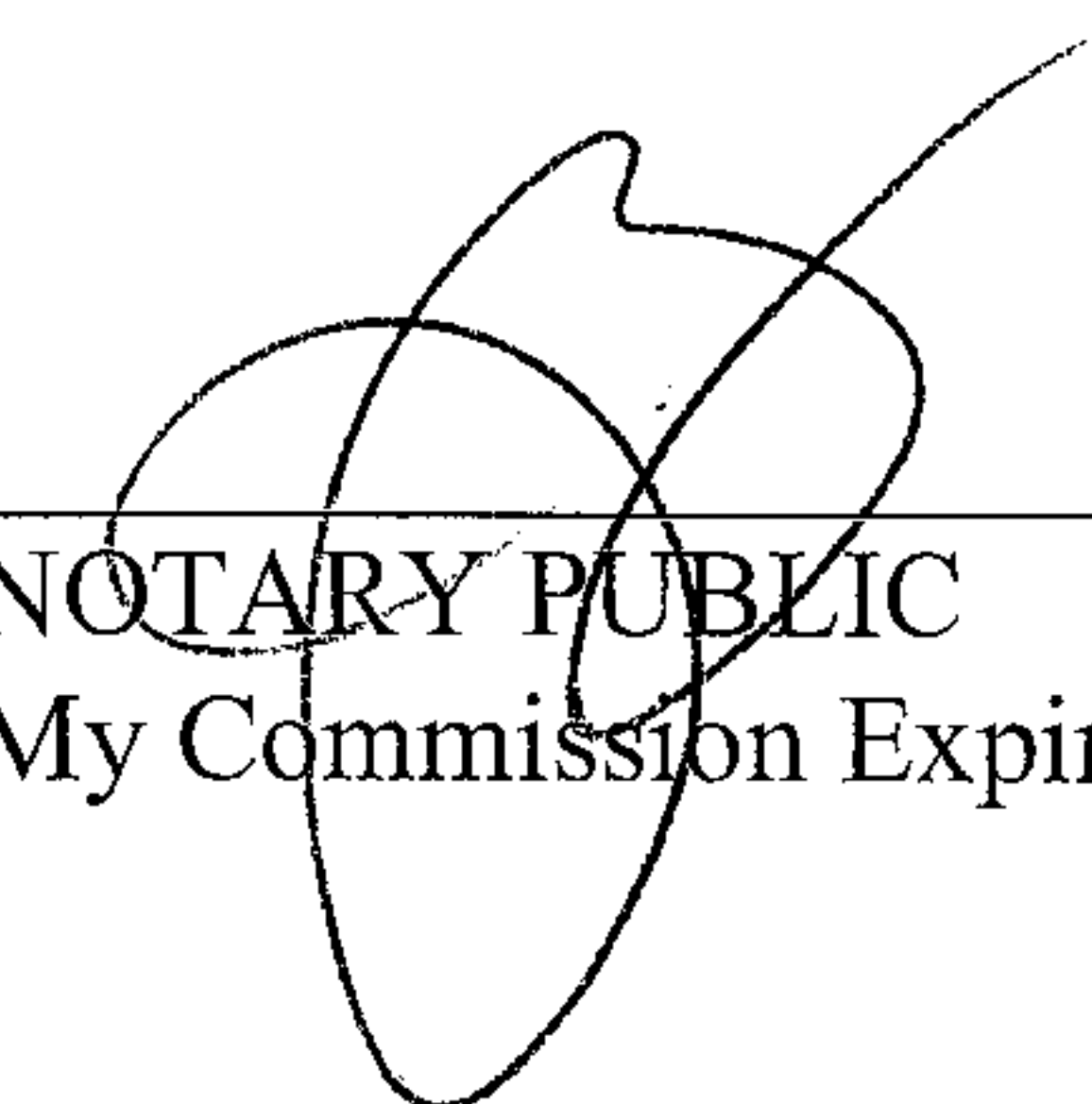
