KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of July, 2005, Jorge L. Arciga, a married man and Gabriella Rios, his married spouse, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Alliance, A Alabama LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050713000350490; re-recorded in Instrument Number 20050826000441300, said mortgage having subsequently been transferred and assigned to Federal National Mortgage Association ("Fannie Mae"), by instrument recorded in Instr 20160928000355650, in the aforesaid Probate Office ("Transferee"); and

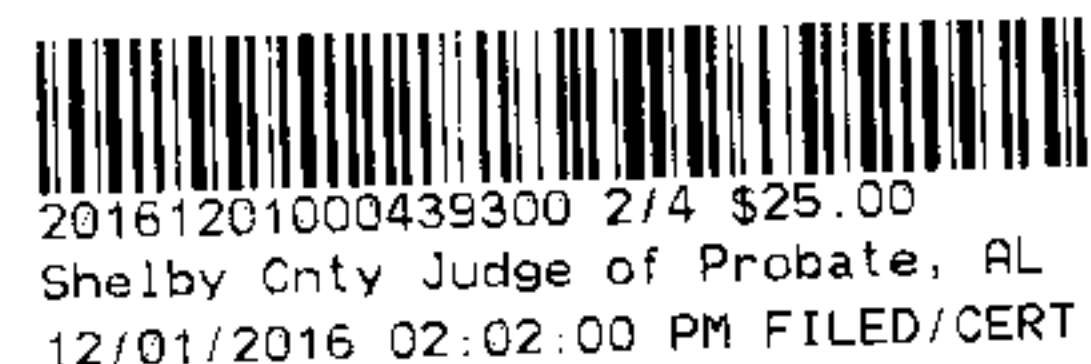

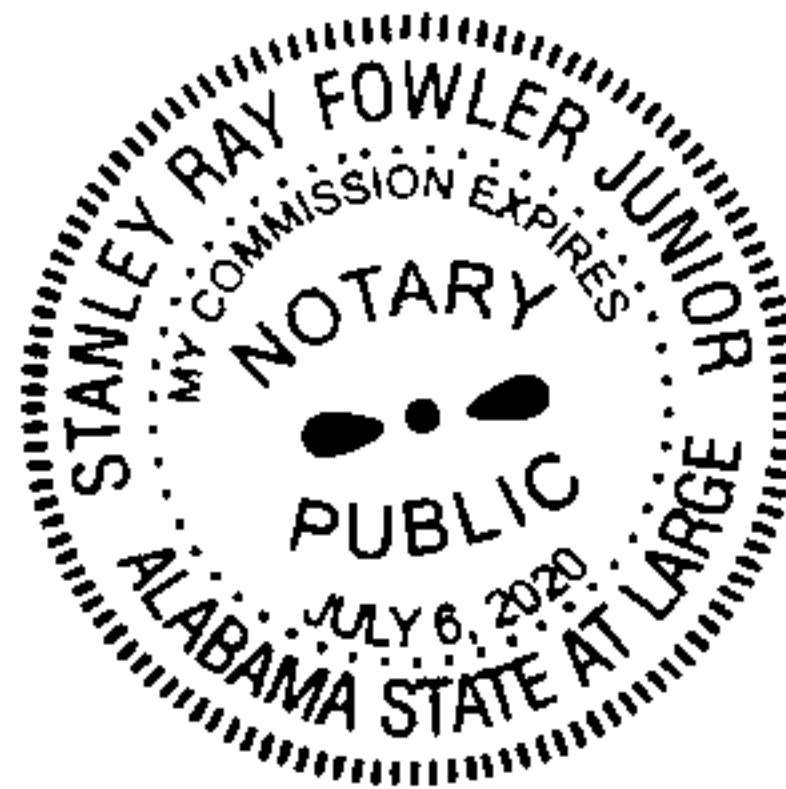
