# ARTICLES OF INCORPORATION OF CHELSEA CREEK COMMUNITY CHURCH

Pursuant to the provisions of the Alabama Nonprofit Corporation Law, the undersigned hereby sets forth and adopts the following Articles of Incorporation.

## ARTICLE I - NAME

The name of the nonprofit corporation shall be Chelsea Creek Community Church. It is hereinafter sometimes referred to as "the Church."

## ARTICLE II - PURPOSE

The Church is organized and shall be operated exclusively for religious, charitable and educational purposes within meaning of Section 501(c)3 of the Internal Revenue code or the corresponding provision of any future United States tax code.

## ARTICLE III – DURATION

The period of duration of the Church shall be perpetual.

## ARTICLE IV - REGISTERED AGENT AND REGISTERED OFFICER

The initial registered agent of the Church is Matthew Roskam.

The initial registered office of the Church is 48 Chesser Crane Rd, Chelsea, AL 35043.

## ARTICLE V – INCORPORATOR

## ARTICLE VI – MEMBERSHIP

The Church shall have members.

## ARTICLE VII - REGISTERED AGENT AND REGISTERED OFFICER

The initial registered agent of the Church shall be Matthew Roskam.

The initial registered office of the Church is 48 Chesser Crane Rd, Chelsea, AL 35043.

## ARTICLE VIII - LIMITATION OF LIABILITY OF DIRECTORS AND OFFICERS

The Church hereby indemnifies the directors and officers against the liabilities described in this paragraph to the full extent permitted by law. Every director and every officer of the Church shall be indemnified by the Church against all expenses and liabilities, including attorney's fees, reasonably incurred by or imposed upon him or her in connection with a proceeding or any settlement of any proceeding to which he or she may be a party or in which he or she may become involved by reason of his or her being, or having been, a director or officer at the time such expenses are incurred, except when the director or officer is adjudged guilty of willful misfeasance in the performance of his or her duties. The foregoing right of indemnification shall be in addition to and not exclusive of all rights to which such director or officer may be entitled. The board of directors shall be authorized to purchase directors and officers liability insurance providing coverage to the officers and directors of the Church at the expense of the Church.

## ARTICLE IX - PROHIBITIONS

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of its purpose. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this Certificate, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE X - DISSOLUTION

Upon the dissolution of the corporation, assets shall be applied and distributed as follows:

- (a) All of the liabilities and obligations of the corporation shall be paid, satisfied, and discharged or adequate provisions shall be made therefore;
- (b) Assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs because of said dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
- (c) Upon the dissolution of the Corporation, its property shall be applied and distributed as follows: (1) all liabilities and obligations of the Corporation shall be paid and discharged or adequate provision shall be made therefore; (2) pursuant to a plan adopted by the board of directors, assets shall be transferred or conveyed to one or more domestic or foreign corporation, society, or organization that qualify as exempt organizations under section 501(c)(3) of the Code and are engaged in activities substantially similar to those of the corporation.
