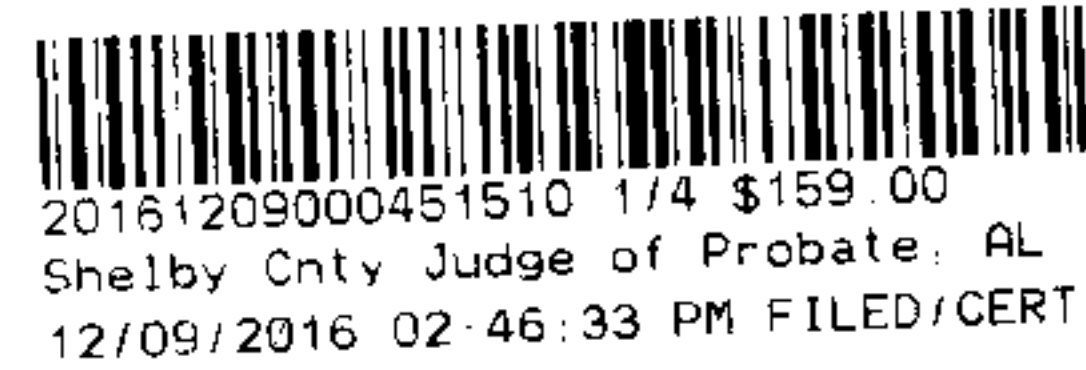

CERTIFICATE OF FORMATION

ARTICLE I

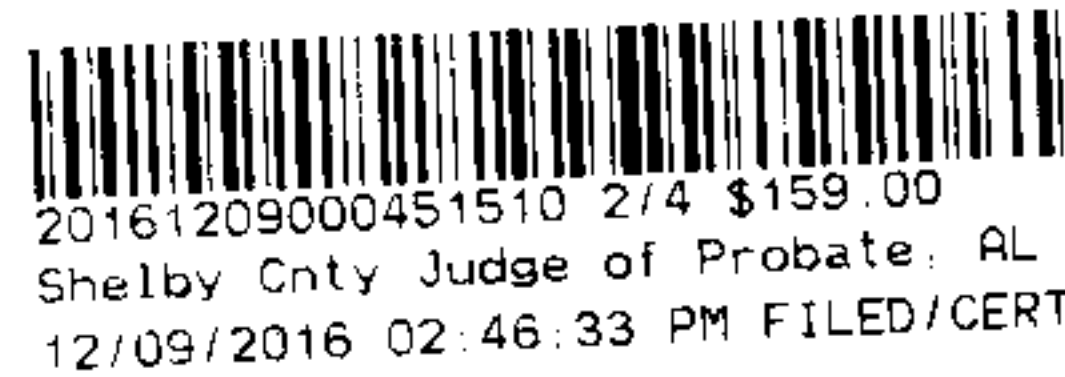

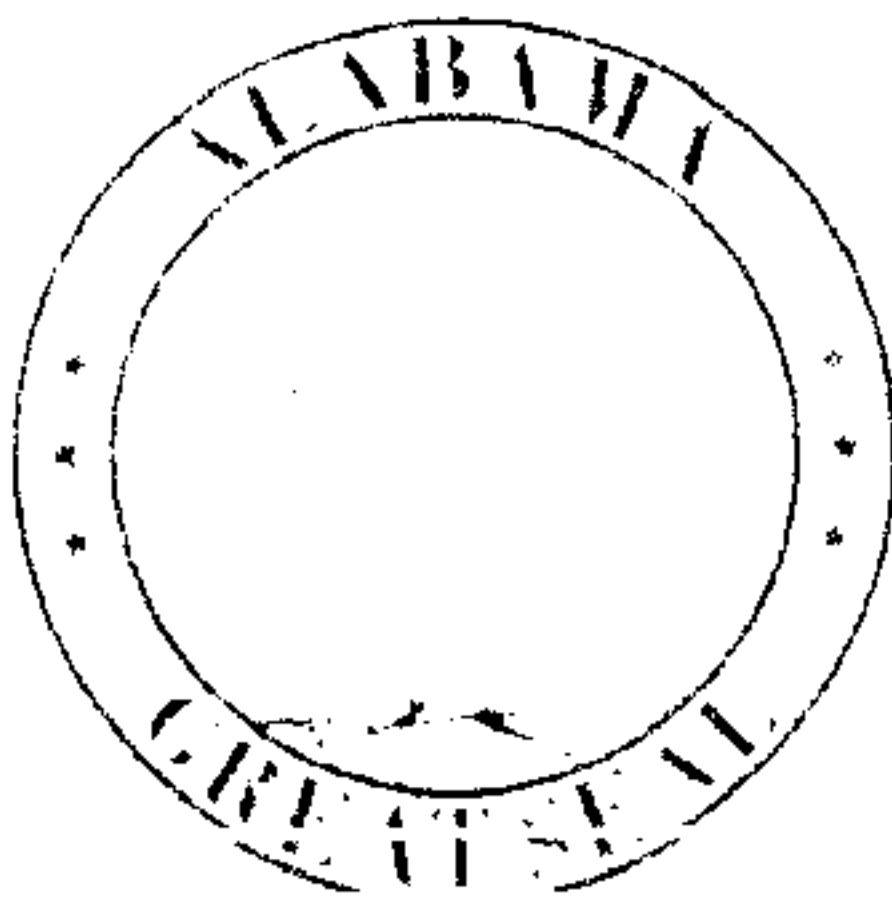
