(herein referred to as "Grantor"), does by these presents REMISE, RELEASE, QUITCLAIM AND CONVEY unto

(herein referred to as "Grantee"), any and all right, title, interest and claim of Grantor in and to the following described real property (herein referred to as the "Property") situated in Shelby County, Alabama (being unimproved acreage property located on Old Highway 280, Westover, Alabama, and having an **Assessor's Market Value of \$133,000.00**, as can be verified by the records of the Shelby County, Alabama Property Tax Commissioner - Parcel No. 08 9 30 0 001 001.000), to-wit:

A tract of land containing six (6) acres more or less and being a part of the original W. L. Hughes and wife Edna E.
