

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of Four Hundred Sixty Two Thousand Eight Hundred Sixty Four and NO/100 Dollars (\$462,864.00) to the undersigned grantor, PINE MOUNTAIN PRESERVE, INC., a Delaware corporation (herein referred to as "Grantor"), in hand paid by Grantee named herein, the receipt of which is hereby acknowledged, the said PINE MOUNTAIN PRESERVE, INC., a Delaware corporation, does by these presents, grant, bargain, sell and convey unto EDDLEMAN RESIDENTIAL, LLC, an Alabama limited liability company (hereinafter referred to as "Grantee", whether one or more), the following described real estate (the "property"), situated in Shelby County, Alabama, to-wit:

Grantee acknowledges that it has made its own independent inspections and investigations of the subject property and is purchasing the property in reliance thereof. For purposes of this paragraph, Grantor shall mean and refer to Pine Mountain Preserve, Inc., and (i) its partners, employees and officers and members of each of them and (ii) any successors and assigns of Pine Mountain Preserve, Inc...
