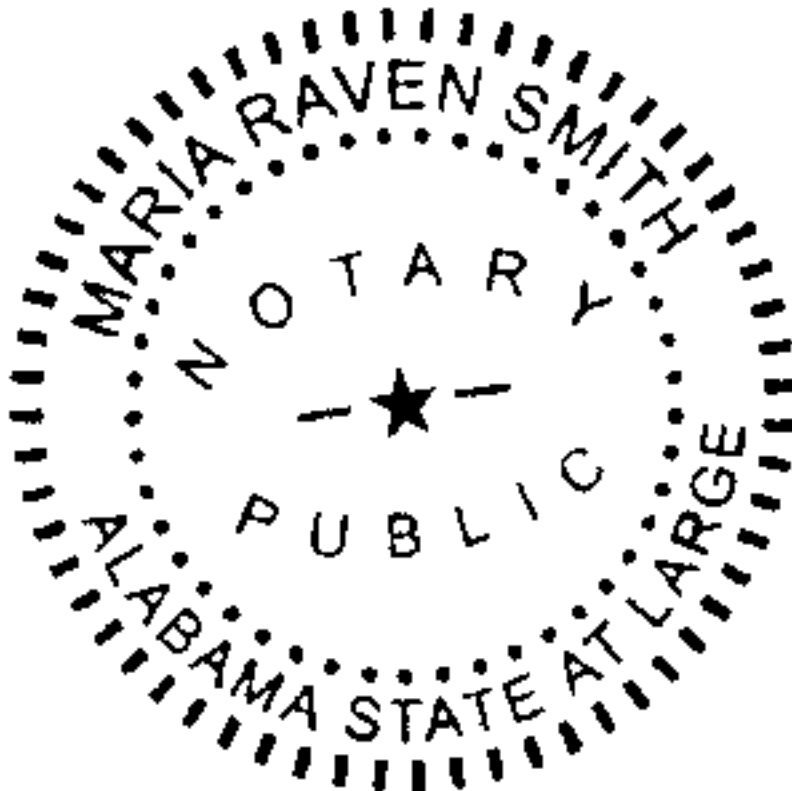

**POWER OF ATTORNEY
