KNOW ALL MEN BY THESE PRESENTS, THAT

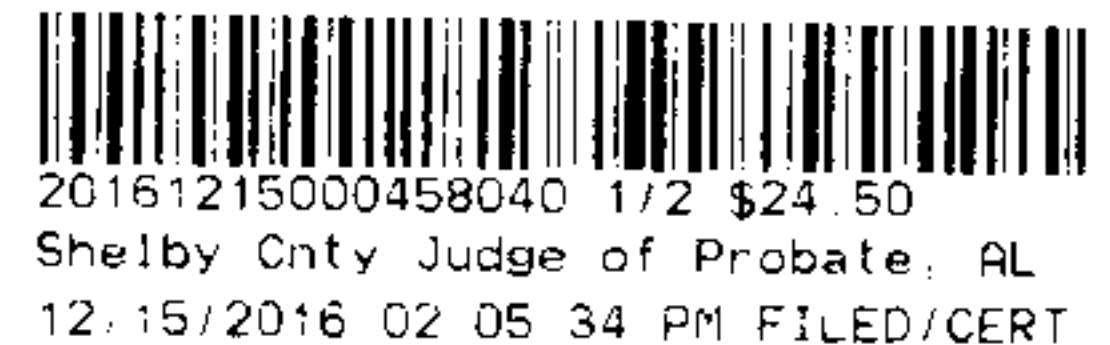


