TERMINATION OF LEASE AGREEMENT

WHEREAS, THE PUBLIC PARK AND RECREATION BOARD OF JEFFERSON COUNTY, a public corporation organized under the laws of the State of Alabama (the "Board"), **YOUNG MEN'S CHRISTIAN ASSOCIATION OF BIRMINGHAM**, a nonprofit corporation organized under the laws of the State of Alabama ("YMCA"), and **REGIONS BANK**, an Alabama banking corporation (the "Bondholder"), have entered into that certain Financing and Lease Agreement dated December 30, 2010 (as heretofore amended or supplemented, the "Lease Agreement") relating to the issuance of that certain \$4,780,000 Revenue Bond (YMCA Project – Greystone Branch), Series 2010-B (the "Bond");

WHEREAS, pursuant to the Lease Agreement, the Board issued the Bond and made the proceeds thereof available to the YMCA in order to finance certain facilities for the health and wellness of families and individuals, and the YMCA agreed to make rental payments to the Board sufficient to pay, among other things, all debt service on the Bond; and

WHEREAS, a Memorandum of Lease dated as of December 30, 2010, has been recorded at Instrument Number 20110104000000340 in the Office of the Judge of Probate of Shelby County, Alabama (the "Memorandum of Lease"), in order to establish of record the existence of the Lease Agreement.

NOW, THEREFORE, the Board, the YMCA and the Bondholder do hereby terminate the Lease Agreement and the Lease Memorandum in their entirety, effective on and as of December 16, 2016.

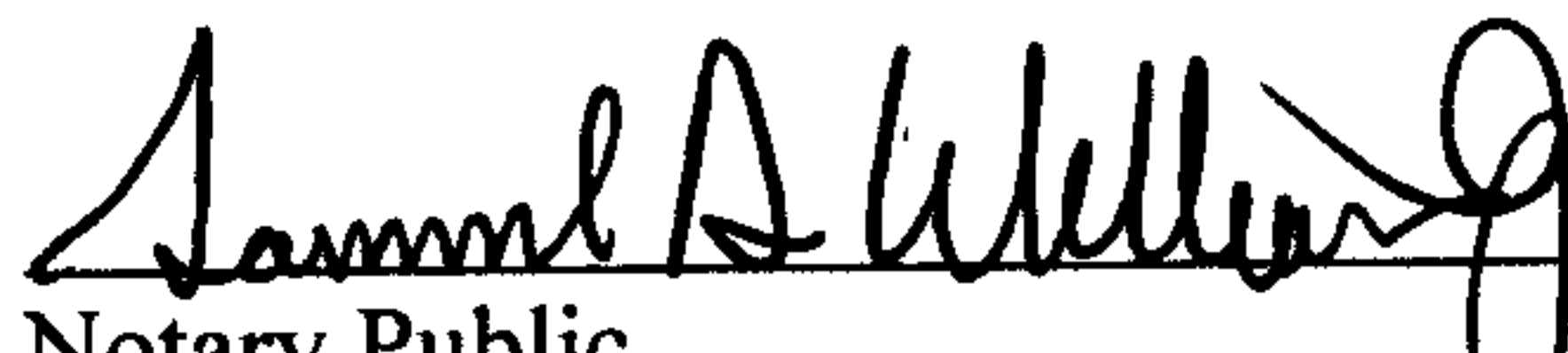
