

## MORTGAGE MODIFICATION AGREEMENT

Evidenced by a Balloon Real Estate Note or the loan documents dated October 17, 2011 and mortgage dated simultaneously therewith, filed in the Probate office of the County named above on the 24TH day of OCTOBER, 2011 in Instrument No. 20111024000316360in the original amount of \$456,700.00 payable in Monthly installments of \$1,575.00 due each Month on the 30<sup>th</sup> day of each month with a balloon payment of \$455,433.02, with the loan term of 5 years with a Maturity Date of October 30, 2016.
