**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of the sum of One-hundred ninety-five thousand (\$195,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Kevin G. Grice and Frances Grice, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Anthony G. Kingston and Tammy H. 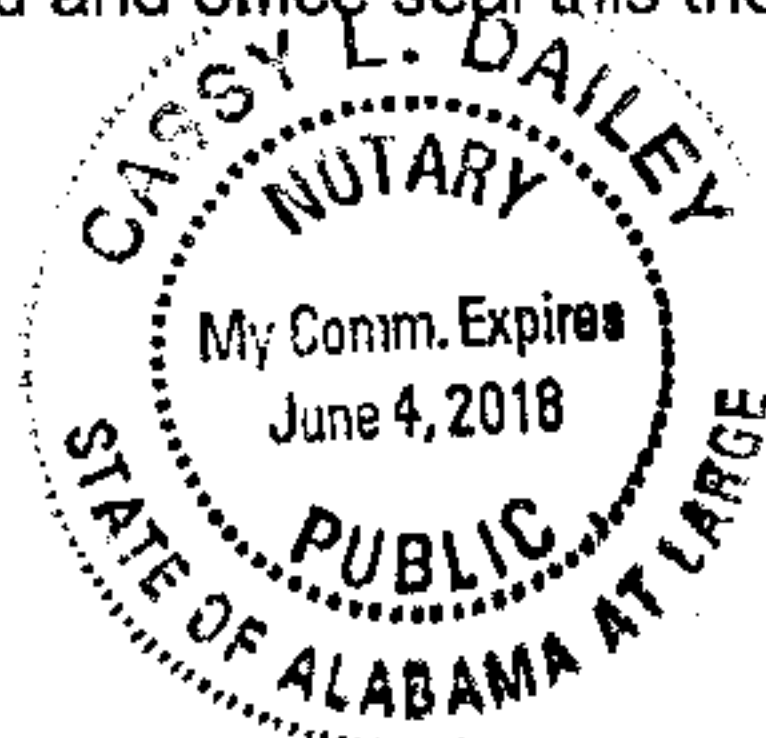


