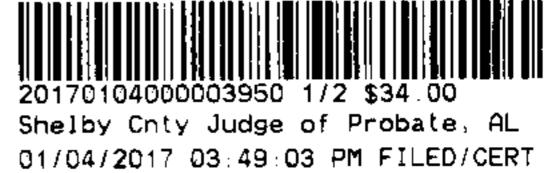

CORPORATION WARRANTY DEED

Joint Tenancy With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Two Hundred Eighty Five Thousand Eight Hundred Ninety One Dollars and No Cents (\$285,891.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Harris Doyle Homes, Inc. (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Brittany Nicole Allums and Jesse Craig Snowden (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:
