


# **CERTIFICATE OF FORMATION**

Pursuant to the Alabama Limited Liability Company Law as set forth in Chapter 1 and Chapter 5 of the Alabama Business and Nonprofit Entity Code (the "Code"), the undersigned hereby adopts the following Certificate of Formation:

## **ARTICLE I NAME**

The name of the limited liability company is Aydp, LLC (the "Company").

## **ARTICLE II TYPE**

The Company is a limited liability company.

## **ARTICLE III DURATION**

The Company shall have perpetual duration unless it is dissolved and its affairs wound up in accordance with the Code or the Operating Agreement of the Company.

## **ARTICLE IV PURPOSE**

The purpose for which the Company is formed is to transact any or all lawful business for which limited liability companies may be formed under the Code, all of which are expressly authorized by this Certificate of Formation.
