Subject to Mineral and Mining rights of record.

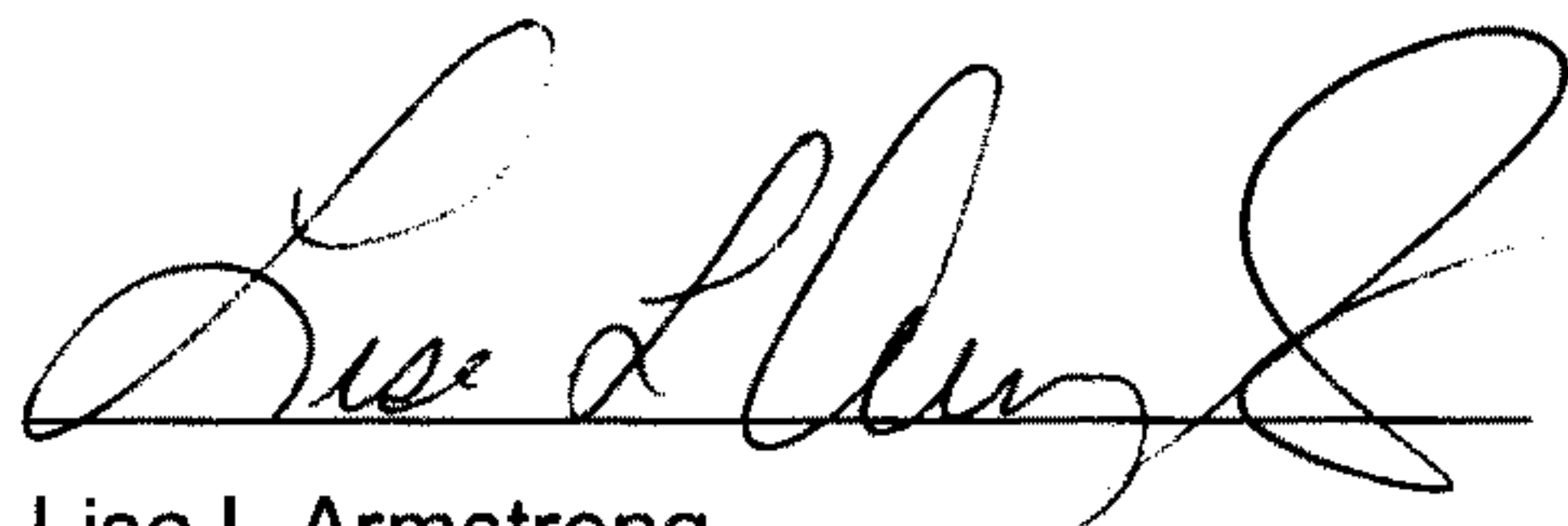
\$150,505.00 of the purchase price was obtained by a purchase money mortgage filed simultaneously herewith.

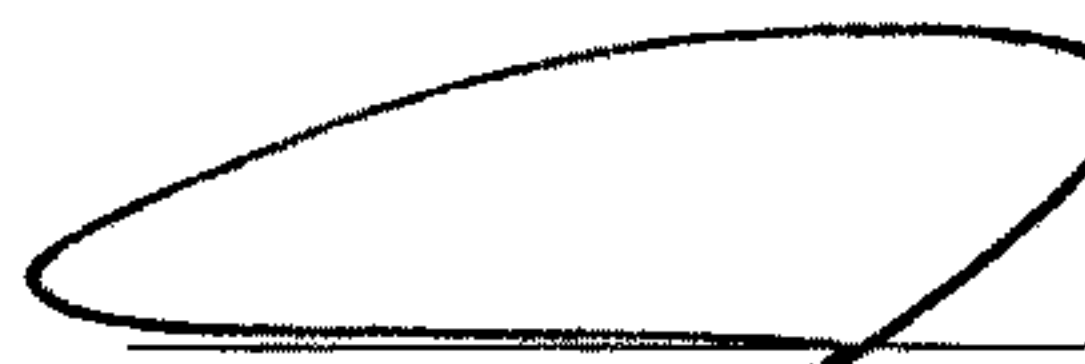

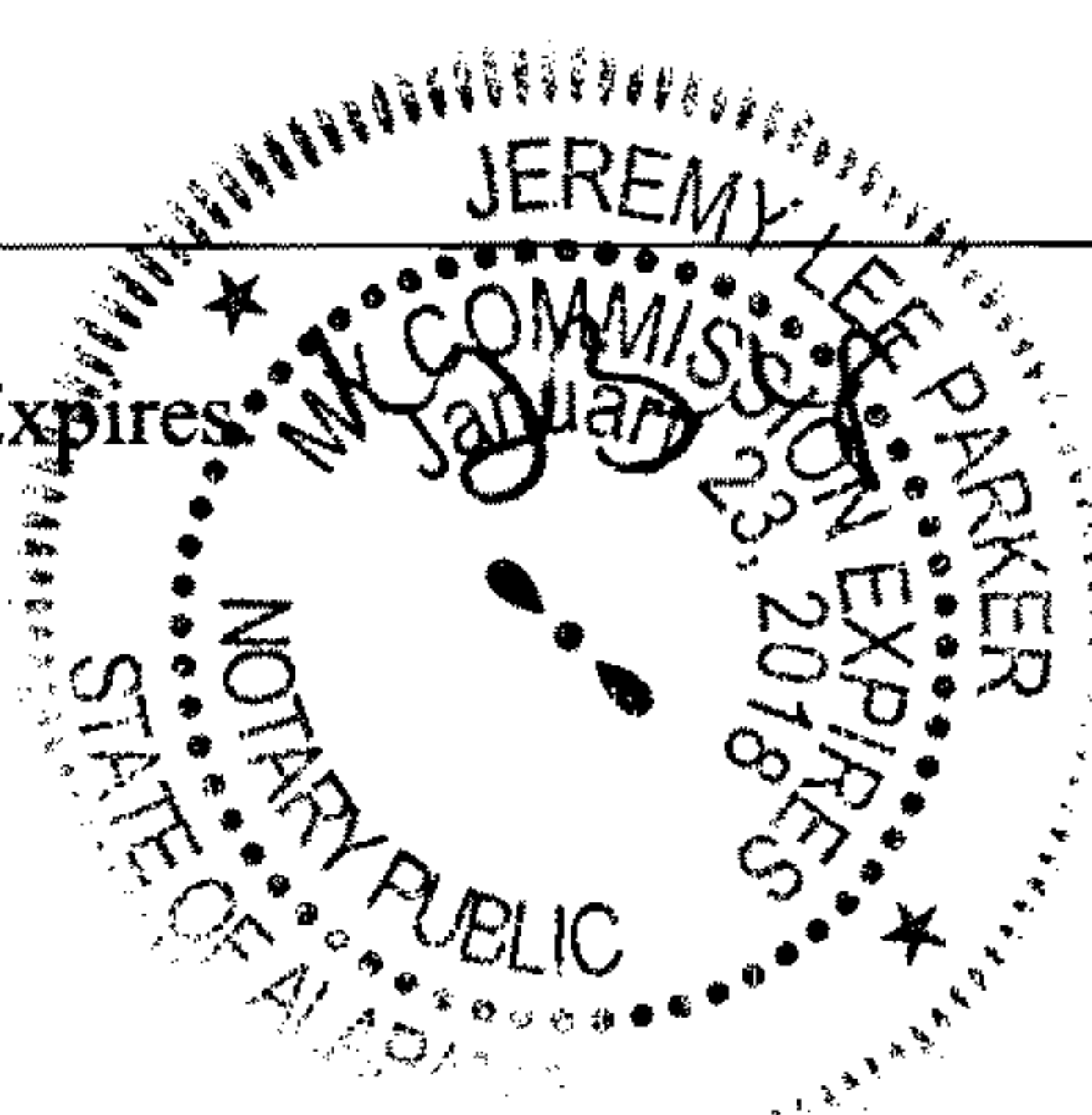
