

ORDINANCE NO. 10515-12-16

AN ORDINANCE TO AMEND ORDINANCE NO. 10515.

WHEREAS the Town of Harpersville approved and adopted Ordinance No. 10515 on or about the 5th day of October, 2015 reestablishing the Harpersville Municipal Court pursuant to Section 12-14-19 of the Code of Alabama, 1975, *as amended*; and

WHEREAS Section II of Ordinance No. 10515 specified the effective re-establishment date of the Harpersville Municipal Court as January 12, 2016 at 9:00am, said date being not less than 90 days subsequent to the adoption of Ordinance No. 10515; and

WHEREAS the Circuit Court of Shelby County, Alabama, in Case No. 58-CV-2010-900183.00 entered an Order on or about the 31st day of August, 2016 ordering, *inter alia*, the re-establishment of the Harpersville Municipal Court; and

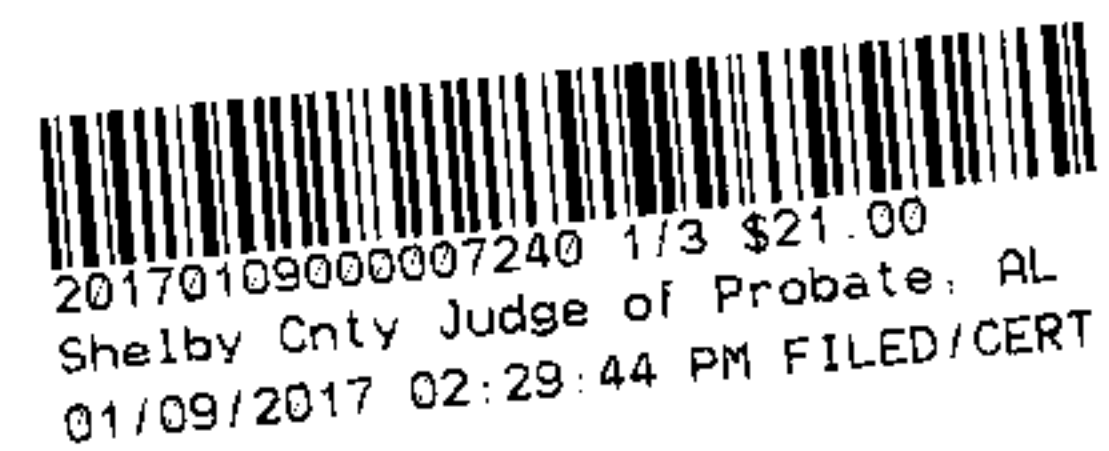
WHEREAS the Circuit Court of Shelby County, Alabama's August 31, 2016 Order approved the Policies and Procedures of the Harpersville Municipal Court; and

WHEREAS the Harpersville Municipal Court has complied with the requirements contained within the Circuit Court of Shelby County, Alabama's August 31, 2016 Order;


BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE TOWN OF HARPERSVILLE, ALABAMA, AS FOLLOWS:

SECTION 1: Section II of Ordinance No. 10515 is hereby amended to read as follows:
"The effective date of re-establishment is on or after January 12, 2016, at 9:00 a.m., which is not less than 90 days subsequent to the date of adoption."




