KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two-hundred twenty-seven thousand (\$227,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Troy Poist and wife, Layla Farris Poist (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Steven Dodd Wall and Carri Burnham Wall (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

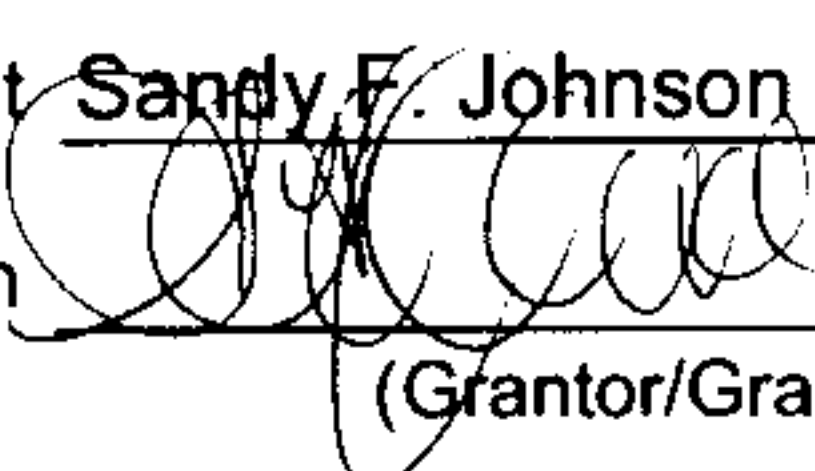
