

CERTIFICATE OF FORMATION
OF

A LIMITED LIABILITY COMPANY
ORGANIZED UNDER THE LAWS OF ALABAMA

Pursuant to Sections 10A-1-3.05 and 10A-5-2.01 of the Alabama Business and Nonprofit Entities Code, the undersigned, as the sole member and organizer of the filing entity named herein, hereby adopt this Certificate of Formation for the purpose of organizing a limited liability company.

1. The name of the filing entity being formed is Gurley Law Firm, LLC, hereinafter referred to in this Certificate of Formation as the "LLC".

2. The type of filing entity being formed is a limited liability company.

3. The LLC shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the LLC, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.

4. The LLC is organized and will be operated for the purpose of engaging in the business of operating a law firm as well as any other lawful business for which a limited liability company may be organized.

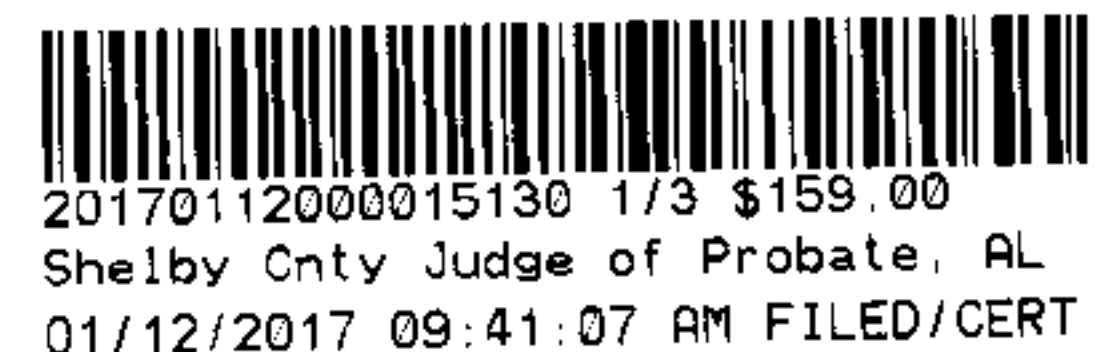
6. The name of the initial registered agent of the LLC is:



In the event a member withdraws or ceases to be a member of the LLC for any reason, such member's interest in the LLC shall be dealt with in accordance with the Operating Agreement of the LLC in effect at the time, and any applicable provisions of the Alabama Business and Nonprofit Entities Code.

10. Upon the dissolution and winding up of the business and affairs of the LLC for any reason, all assets and properties of the LLC remaining after the payment of its debts and obligations shall be distributed exclusively to the members as set forth in the Operating Agreement at that time.

11. The regulation of the internal affairs of the LLC shall be governed by the Operating Agreement of the LLC in effect at that time.

12. Amendments to this Certificate of Formation may be made from time to time by the member(s) of the LLC.
