WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **One Hundred Sixty Thousand and 00/100 Dollars (\$160,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Patricia M. Heath, a married person

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Ronald E. Moore and Carla G. Moore

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 417, according to the Final Plat of Forest Lakes, Sector 5, as recorded in Map Book 34, Page 122 A, B, C, in the Office of the Judge of Probate of Shelby County, Alabama.

\$128,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2017 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantor; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


The above described property does not constitute the homestead of the Grantor or her spouse.

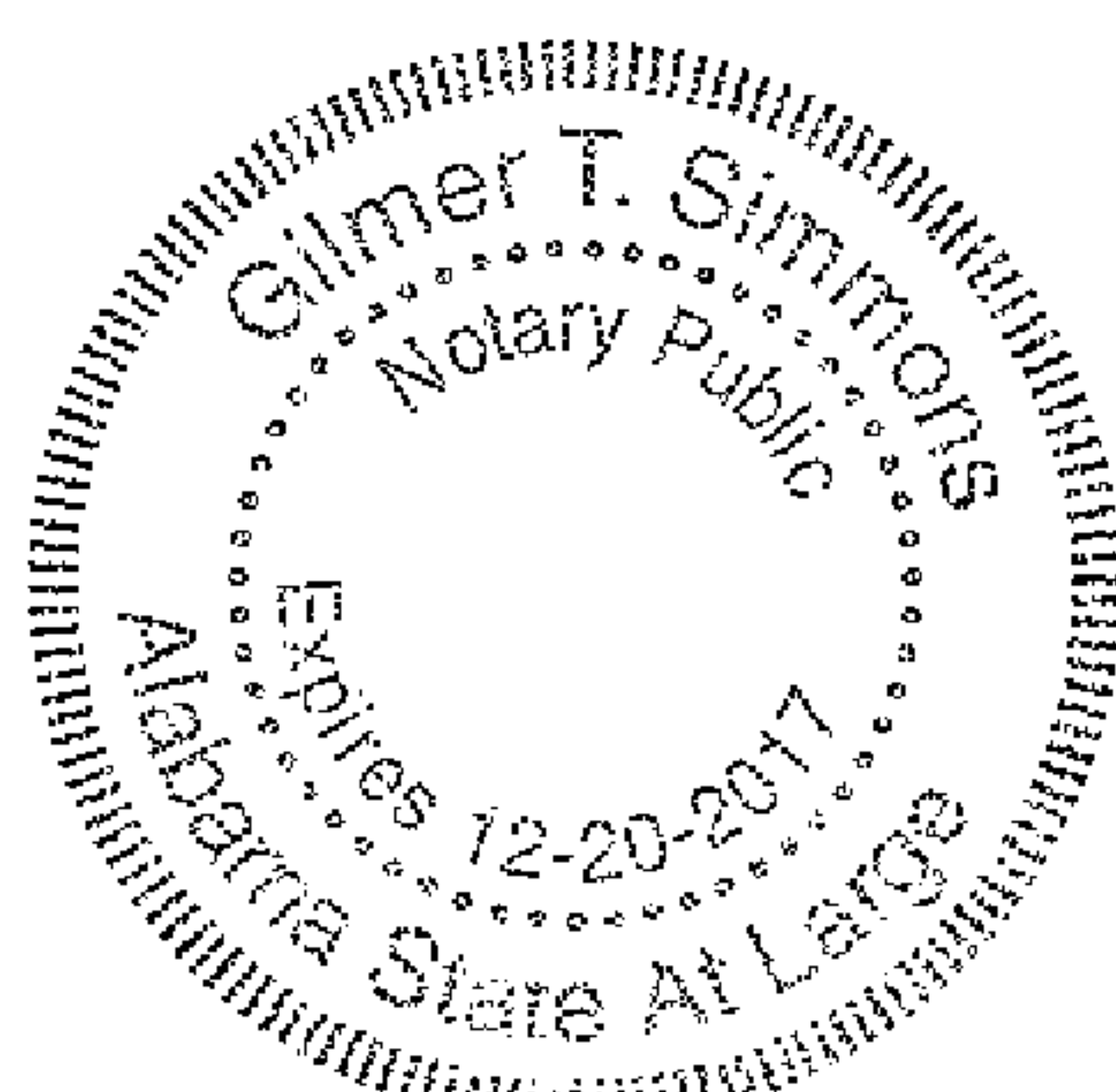
