This Indenture made as of the 30th day of December, in the year **TWO THOUSAND SIXTEEN** between **BROOKHAVEN STUDIO, LLC, A GEORGIA LIMITED LIABILITY COMPANY**, as party or parties of the first part, hereinunder called Grantor, and **TINA L. FOUNTAIN AND JOLLY R. FOUNTAIN** as party or parties of the second part, hereinafter called Grantee (the words "Grantor" and "Grantee" to include their respective heirs, successors and assigns where the context requires or permits).

W I T N E S S E T H that: Grantor, for and in consideration of the sum of TEN AND 00/100'S (\$10.00) Dollars and other good and valuable considerations in hand paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, conveyed and confirmed, and by these presents does grant, bargain, sell, alien, convey and confirm unto the said Grantee, to wit:

All that tract or parcel of land lying and being in Shelby County, Alabama to wit:

The West ½ of the NE ¼, all in Section 10, Township 18, Range 1 East. Also conveyed herein is an easement 20 foot in width and lying on the West side of the following described property:

Start at the SW corner of SE ¼ of NE ¼ of Section 10, Township 18, Range 1 East, run North 2 deg. 30 min. West 660 feet to a point of beginning; thence North 87 deg. 30 min. East 660 feet; thence North 2 deg. 30 min. West 660 feet; thence South 87 deg. 30 min. West 660 feet; thence South 2 deg. 30 min. East 660 feet. This easement shall be for ingress, egress and utilities.

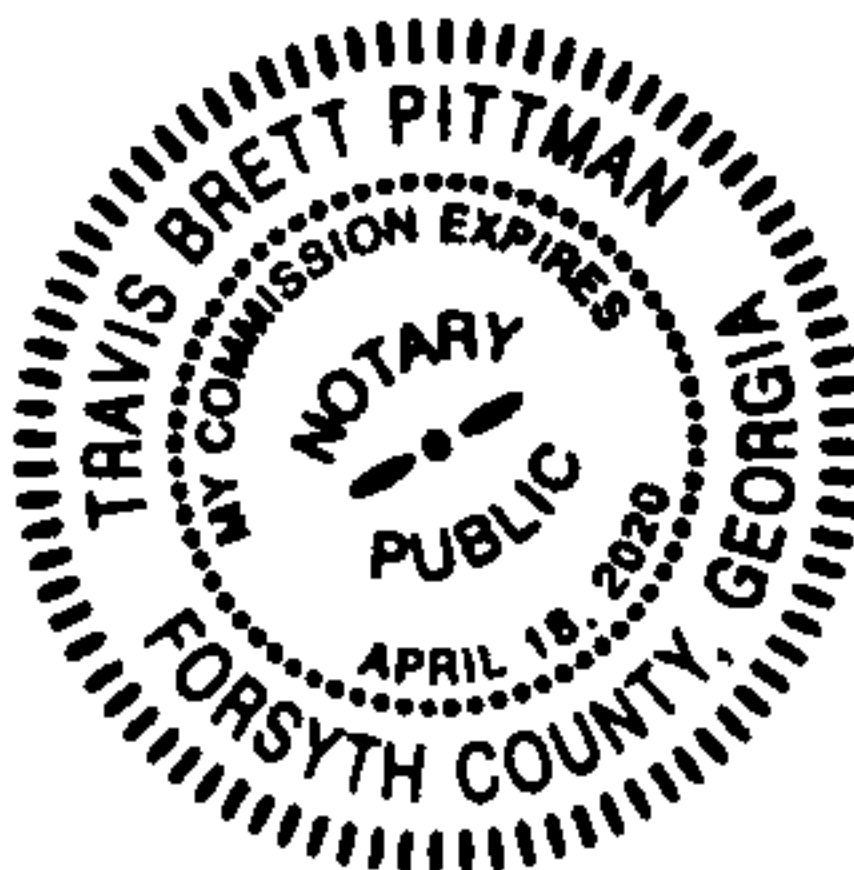
