TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, desiring to form a limited liability company under the laws of the State of Alabama, does hereby adopt the following Certificate of Formation (the "Certificate of Formation"):

**ARTICLE I
NAME**

The name of the limited liability company shall be **GAYLORDS, LLC** (the "Company").

**ARTICLE II
ORGANIZATION**

The Company is hereby organized in accordance with the Alabama Limited Liability Company Law of 2014, Section 10A-5A-1.01 et seq., Code of Alabama, 1975, as amended from time to time (the "LLC Law").

**ARTICLE III
PERIOD OF DURATION**

The term for which the Company is to exist as a limited liability company shall be effective on the date this Certificate of Formation is filed in the office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetual existence or until the Company shall be dissolved (a) upon the written consent of all Members of the Company, (b) as provided in the Limited Liability Company Agreement of the Company (the "LLC Agreement"), or (c) as may be required by the LLC Law or other applicable laws.

ARTICLE IV
LOCATION OF REGISTERED OFFICE
AND NAME OF REGISTERED AGENT

The initial registered office of the Company shall be at 103 Perry Place, Birmingham, Alabama 35242, and the name of the initial registered agent at such address shall be Nick R. Pihakis.

ARTICLE V
MEMBERS

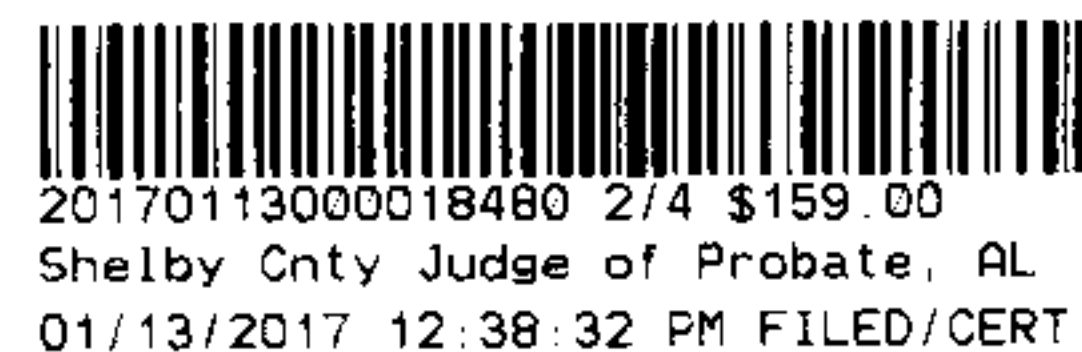

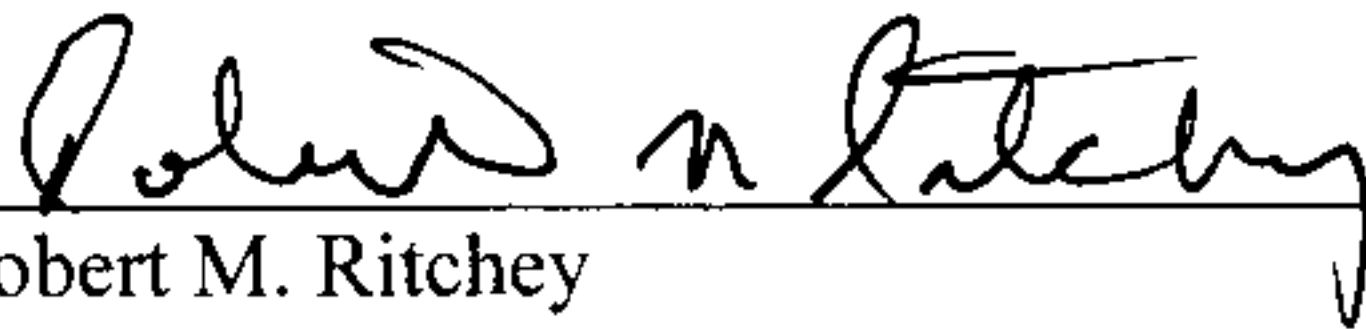

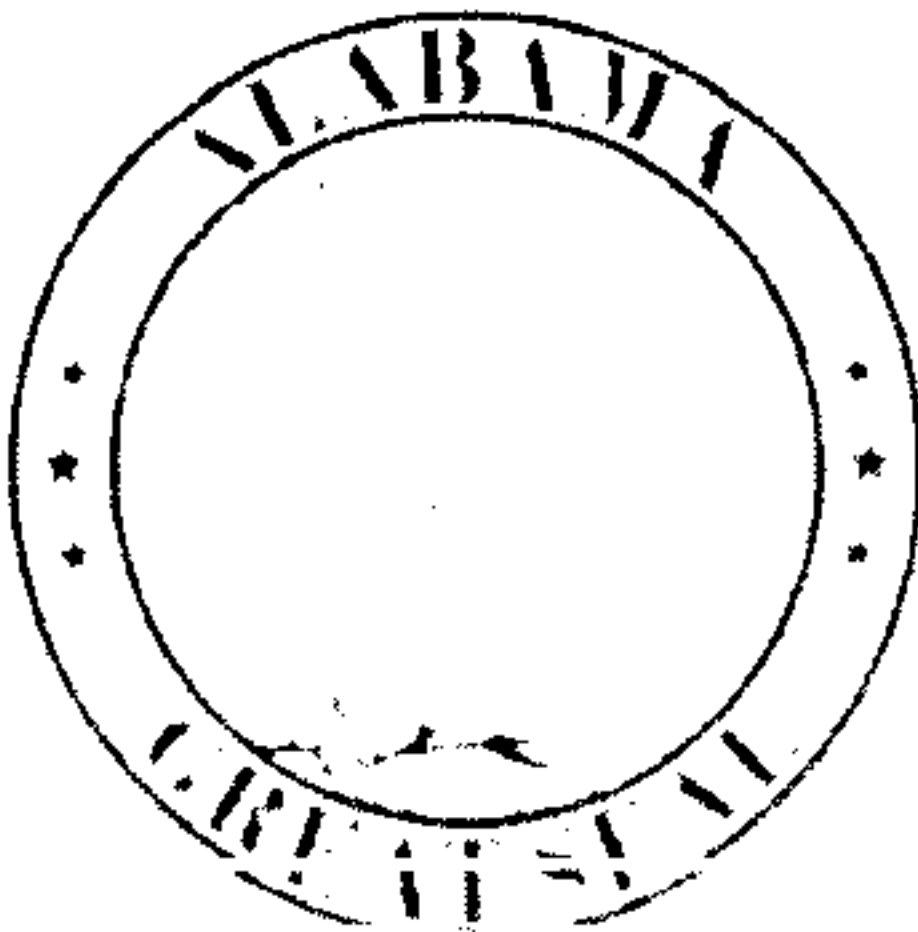
