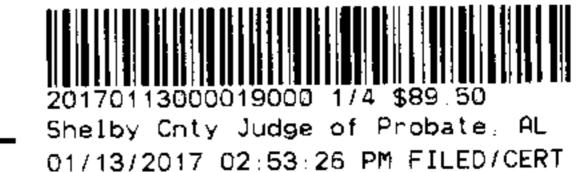

GENERAL WARRANTY DEED

HORTON**, **INC.** – **BIRMINGHAM**, an Alabama corporation ("Grantee"), does, upon and subject to any and all conditions, covenants, easements, exceptions, limitations, reservations, and restrictions hereinafter contained, hereby **GRANT**, **BARGAIN**, **SELL** and **CONVEY** unto Grantee the following described real property lying and being situate in Shelby County, Alabama (the "Property"), towit:

Lot 60, 61 and 62, according to the survey of Kinsale Gardens 3rd Sector, as recorded in Map Book 41, page 90, in the Probate Office of Shelby County, Alabama.

Grantor's conveyance of the Property is subject to the Permitted Exceptions set forth in Exhibit A attached hereto and incorporated herein.
