WHEREAS, heretofore, on to-wit, July 31, 2010, **William D Haselden, Husband And Therese B Haselden, Wife, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for North American Savings Bank, FSB**, which said mortgage is recorded in Instrument No. 20101007000333250, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, on December 15, 2016, the day on which the foreclosure sale was due to be held under the terms of said notice at 12:00 o'clock am/pm between the legal hours of sale, said foreclosure was duly and properly conducted and Branch Banking and Trust Company did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Birmingham, Alabama, the property hereinafter described; and
