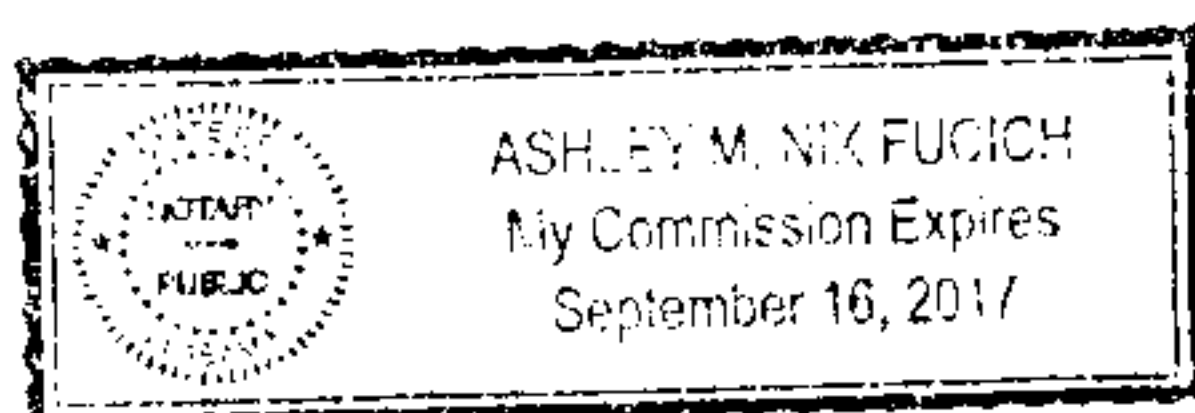

This appointment is made under and by authority of the authority of the Board of Directors of the State of South Dakota, meeting held on the 21st day of July, 2016 to-wit:

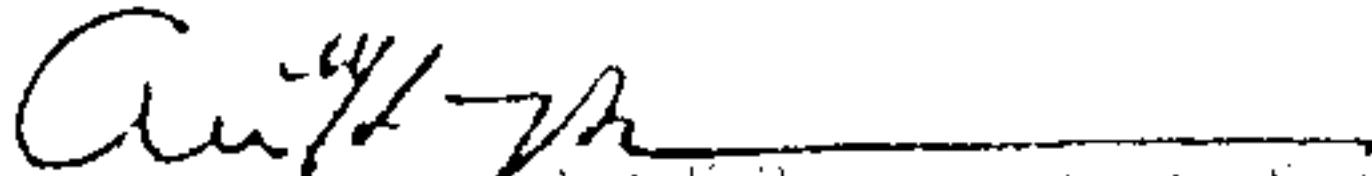
