KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One-hundred sixty thousand five-hundred (\$160,500.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Glenda Corley-Topham, formerly known as Glenda C. Cobb, and husband, Everett G. Topham (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Julie Elizabeth Kinnard and Jacob Len Kinnard (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.






