KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Three Hundred Eight Thousand Four Hundred Fifty and 00/100 (\$308,450.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Jeremy Kent Marshall and wife, Angela Albano Marshall**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Earnest Pitts and Rosa M. Pitts**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:


