WARRANTY DEED



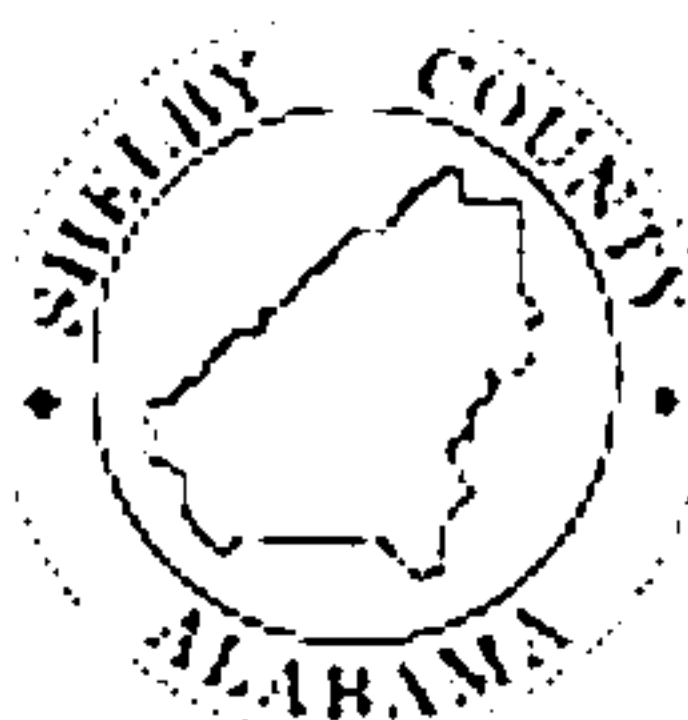
