KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of December, 2005, Ralph Bohanan and Littia Burt, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Meritage Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060104000006600, said mortgage having subsequently been transferred and assigned to MTGLQ Investors, L.P., by instrument recorded in Instrument Number 2016031000078070, in the aforesaid Probate Office ("Transferee"); and

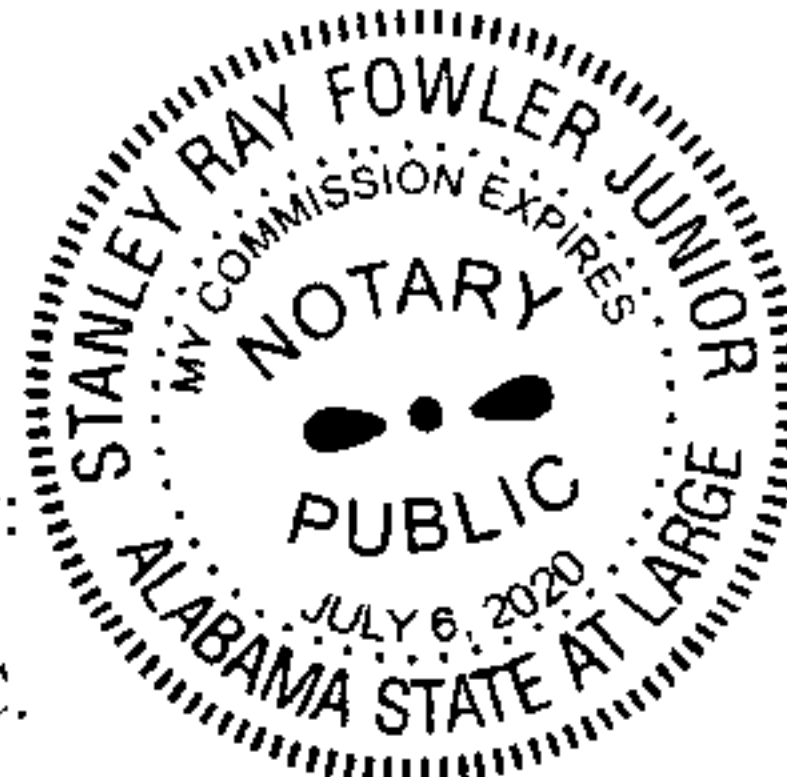
