KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of April, 2010, Joseph F. Pardo, Jr. and Deborah D. 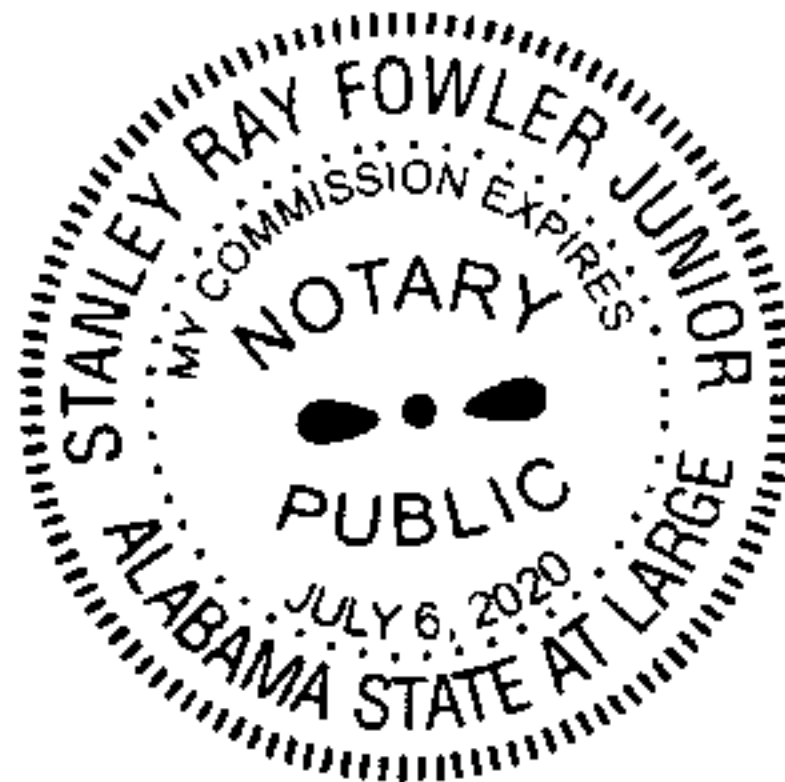


