KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One dollar (\$1.00), cash in hand paid to the undersigned by the Grantee, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), **Shelby Investments, LLC, a Georgia Limited Liability Company**, have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto **Harold Wright and Donna Green Wright** the following described easement, lying and being in Shelby County, Alabama and more particularly described as follows:

An Access Easement across a parcel of land situated in the South half of Section 13, Township 21 South, Range 5 West, Shelby County, Alabama, with Parcel Number 25-6-13-0-000-001.000, being more particularly described as follows:

A 30 feet wide access easement along existing roadway otherwise known as River Road (CR-251) from where the Relocated River Road (CR-251) ties to existing River Road (CR-251) to the west property line of ID No. 25-6-13-0-000-001.000 a distance of 970'±.

And as shown on the Property Plat attached hereto and made a part hereof:

To Have and To Hold, unto Harold Wright and Donna Green Wright, their heirs and assigns, in fee simple forever.

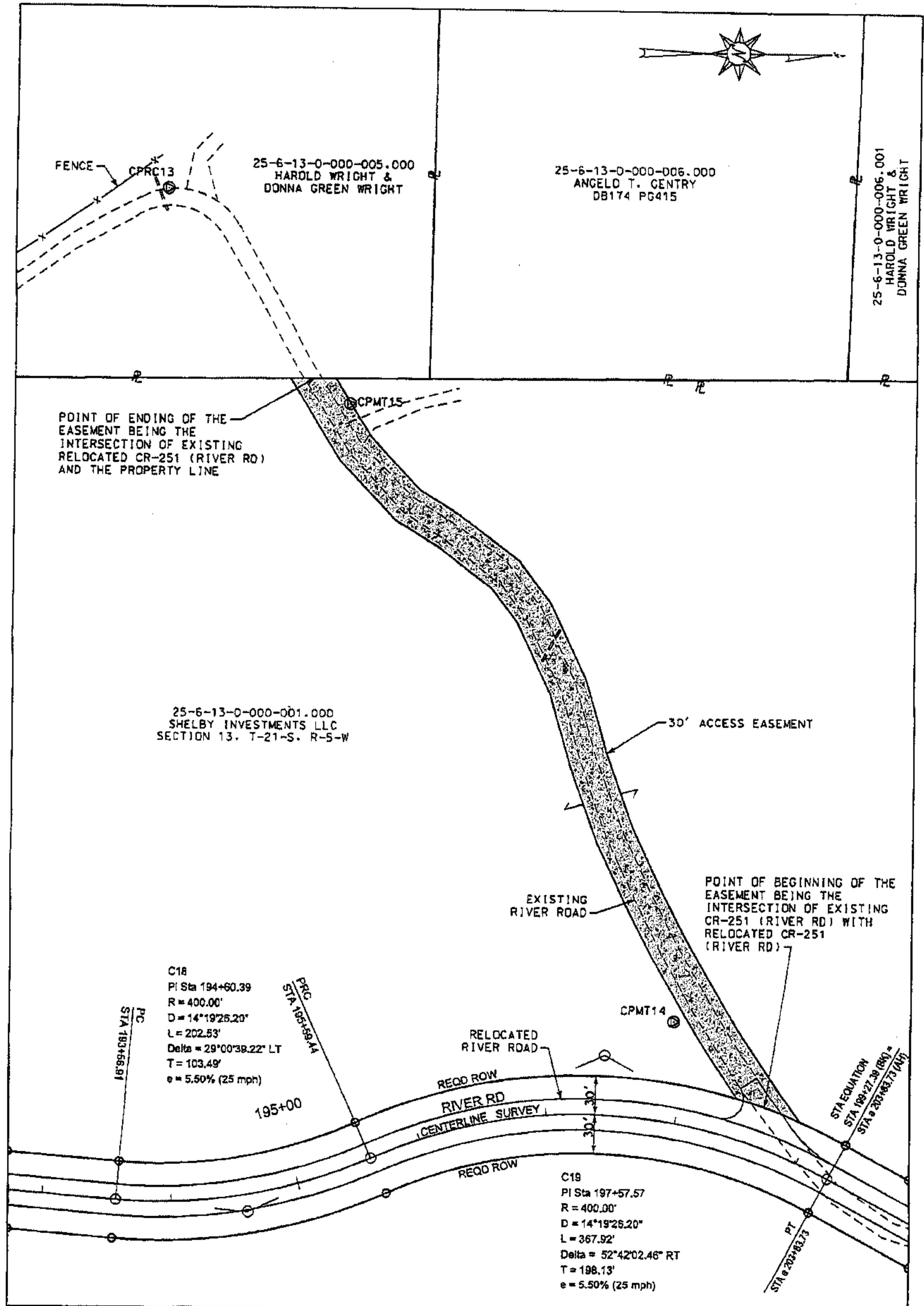
