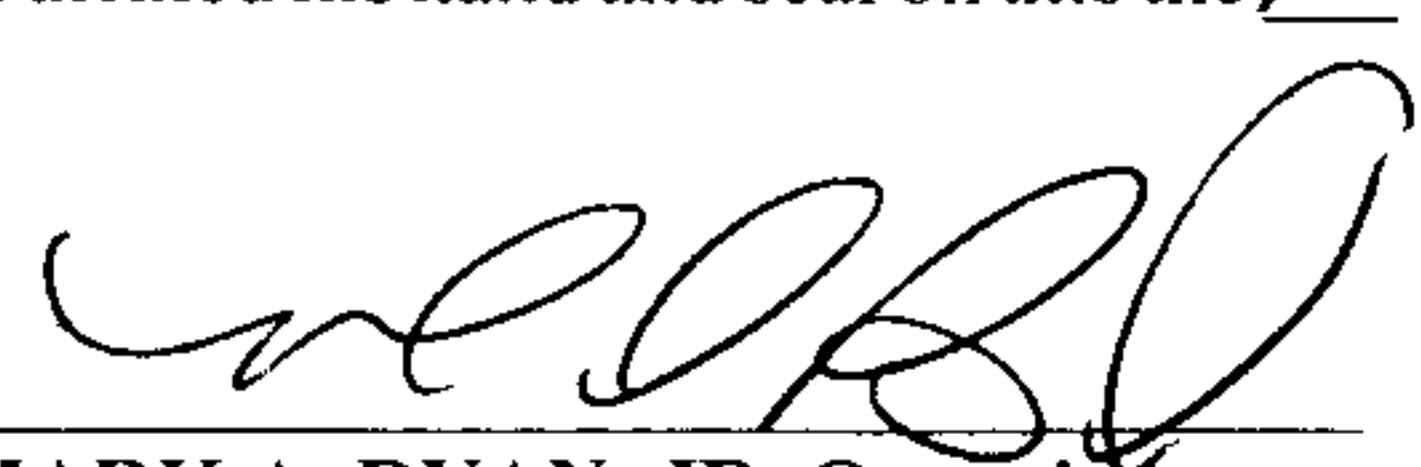
The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certify as follows:
