KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED FORTY-TWO THOUSAND NINE HUNDRED AND NO/100 (\$242,900.00), and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **DENNY C. JOINS AND NORMA C. JOINS, HUSBAND AND WIFE**, (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **JEREMY D. REED AND JERRY C. ANDERSON**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 11, according to the Survey of Chinaberry, Phase I, Final Plat, as recorded in Map Book 32, Page 119, in the Office of the Judge of Probate Shelby County, Alabama.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.

\$194,320.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

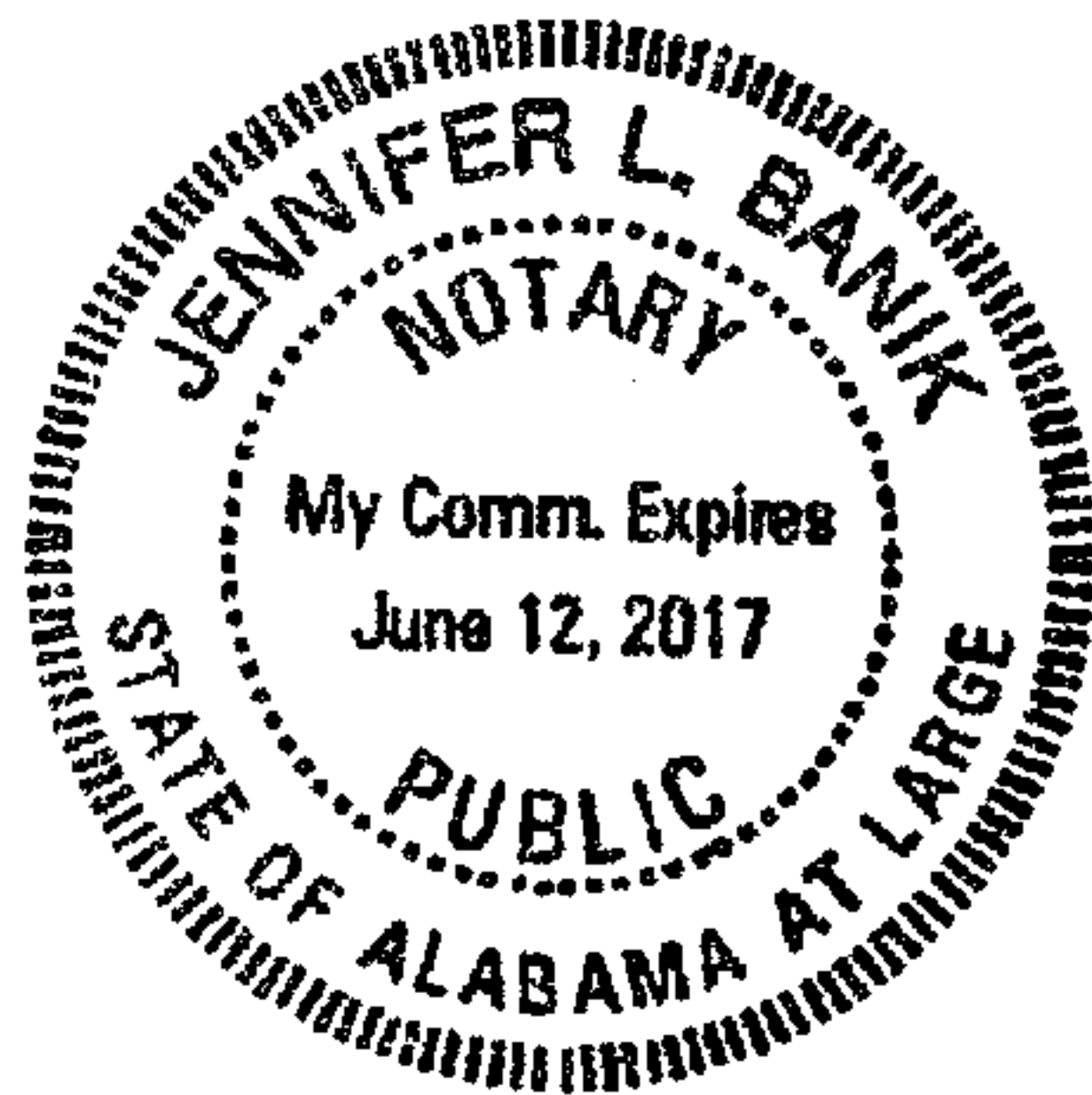
