6. The Trust is a **revocable** trust. Any person holding the power of revocation is named here: **John Daniel Lee.**



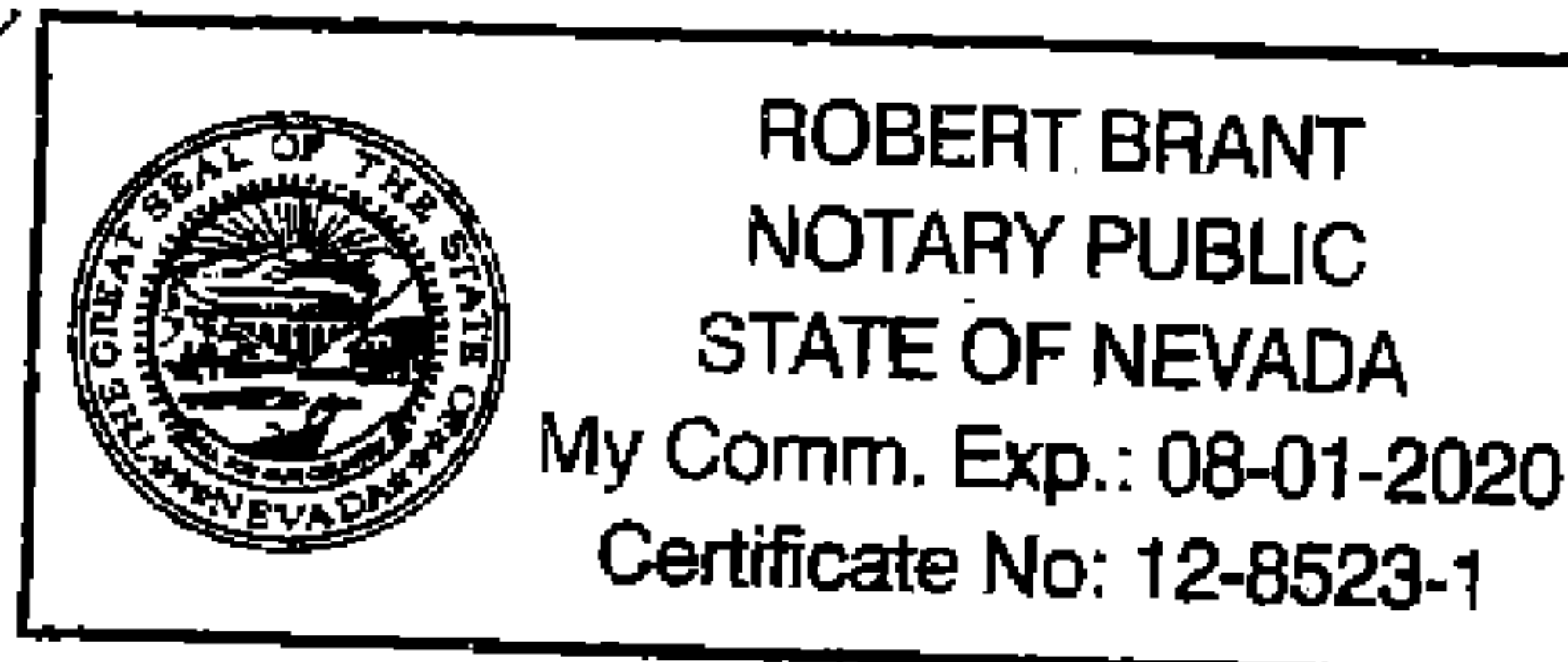
