PARTIAL RELEASE OF JUDGMENT LIEN

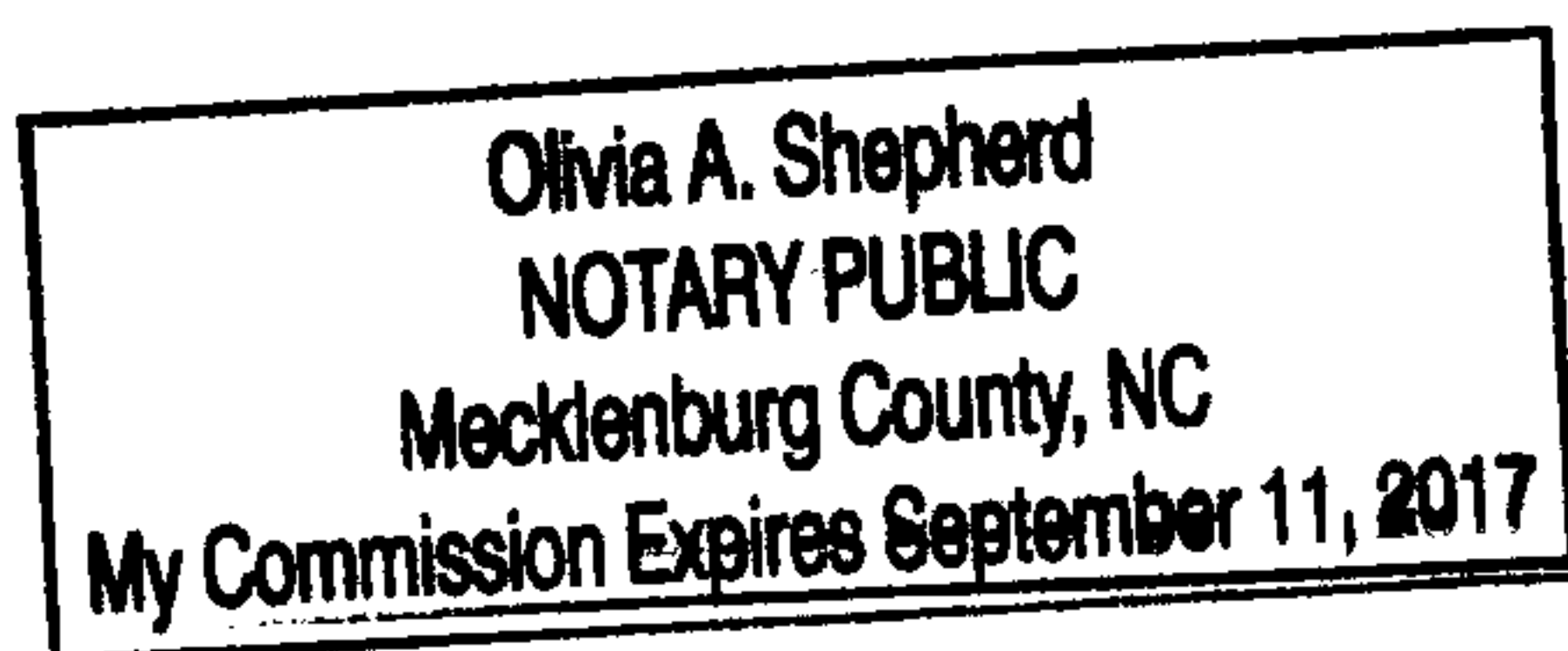

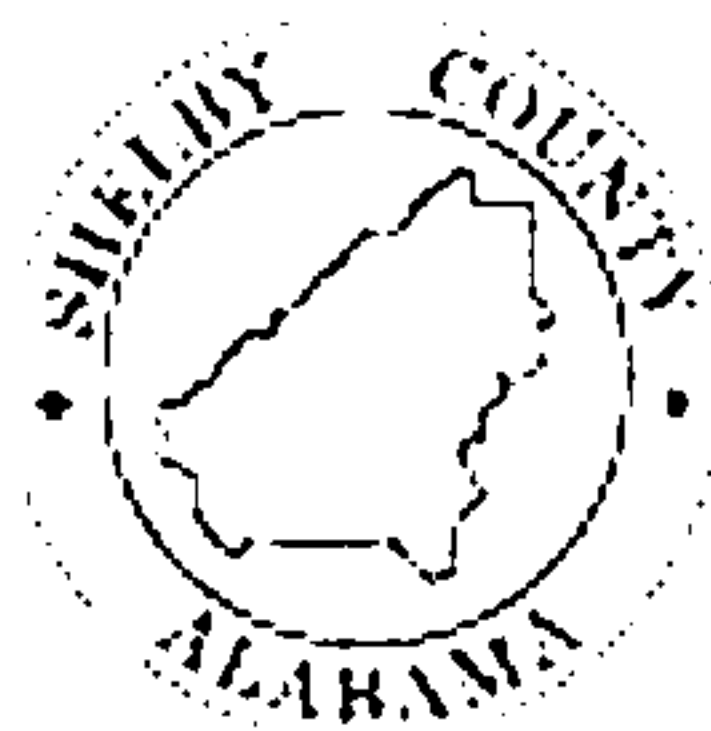
