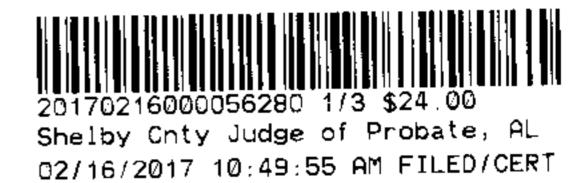
MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That,

WHEREAS, heretofore, on to-wit: July 19, 2007, Charles W. Larimer aka Charles Larimer and Dawn C, Larimer, husband and wife, Mortgagors, executed a certain mortgage to Regions Bank, a corporation, said mortgage being recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument: 20070829000406320; and

WHEREAS, on February 15, 2017, the day on which the foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure sale was duly and properly conducted, and the said Regions Bank, as Mortgagee, did offer for sale and sell at public outcry, in front of the Courthouse door, Main Entrance, Shelby County, Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Regions Bank, in the amount of One Hundred Twenty Two Thousand Six Hundred Eighteen and 43/100 (\$122,618.43), which sum was offered to be credited on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Regions Bank; and
