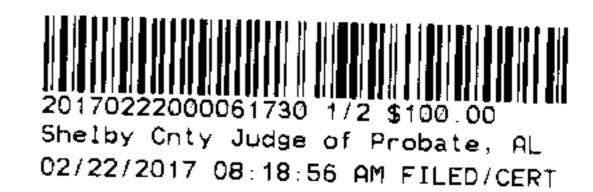
WARRANTY DEED
