




The undersigned, Janice S. Mitchell, being the President and a Director of Driver Refrigeration, Inc., pursuant to the Alabama Business Corporation (Act (Code of Alabama 1975, §10-2A-190, et seq.)), adopt the following Articles of Dissolution for Driver Refrigeration, Inc.

1. The name of the corporation is Driver Refrigeration, Inc.
2. The address of the registered office of the corporation is at 2650 North Chandalar Lane, Pelham, Al 35124. The registered agent for the corporation at such address, Robert Mitchell, is deceased.
3. Robert Mitchell, one of the original incorporators and stockholder, is deceased having died on April 1, 2015, leaving a Last Will and Testament which was filed for probate in Shelby County, Alabama, Case Number PR-2015-000307, and Janice S. Mitchell, the other incorporator and stockholder, was the sole and only beneficiary.
4. The name and address of the stockholder who owns all of the issued shares of the stock in the corporation is: the President and Director Janice S. Mitchell, 2650 North Chandalar Lane, Pelham, Al 35214. The registered agent for the corporation is Janice S. Mitchell.
5. The owner of all issued and outstanding shares of stock of the corporation was present at the call meeting, on December 1, 2016 and unanimously voted to dissolve the corporation pursuant to provisions of Code of Alabama Title 10-2B-14.02.
6. All known debts, obligations and liabilities of the corporation have been paid and discharged or adequate provisions have been made therefor.
7. There are no suits pending against the corporation in any court, or adequate provisions have been made for the satisfaction of any judgment, order, or decree which may be entered against it in a pending suit.
8. By her signature hereto on this date, the said Janice S. Mitchell, President, duly affirms the statements set out herein and affirms the vote to dissolve the corporation as of this date.


