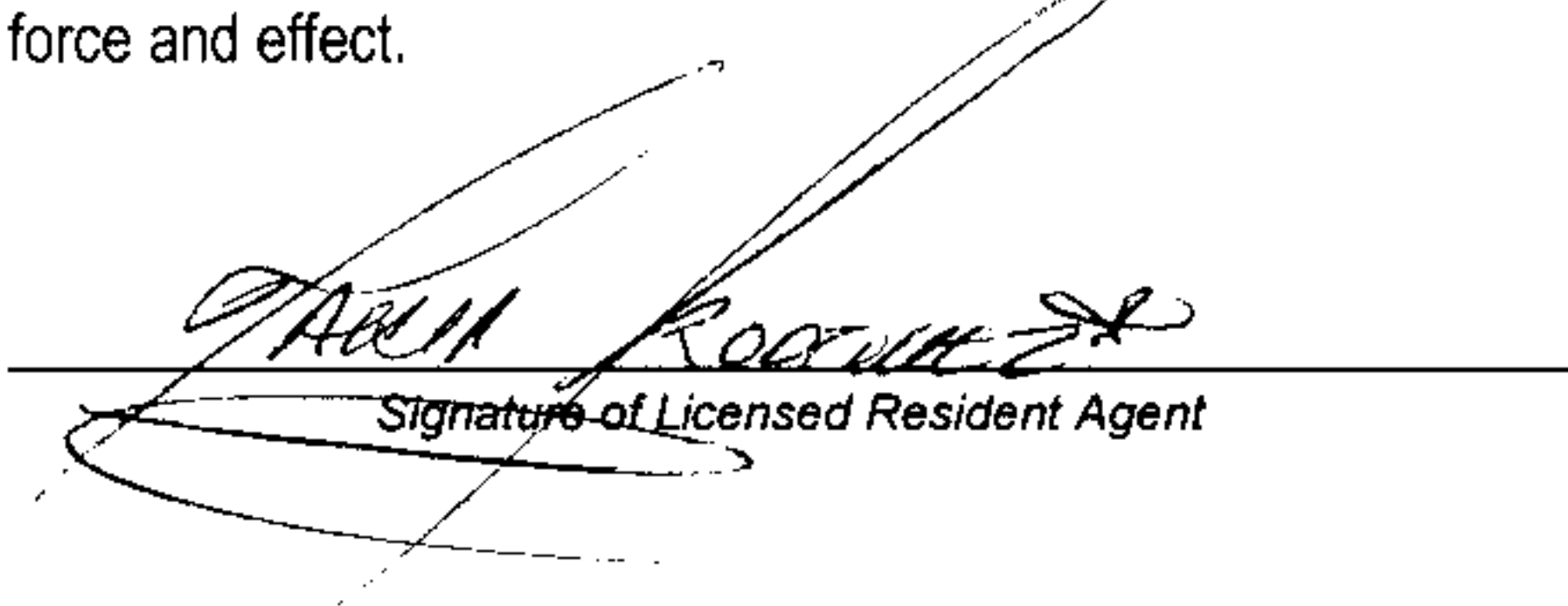

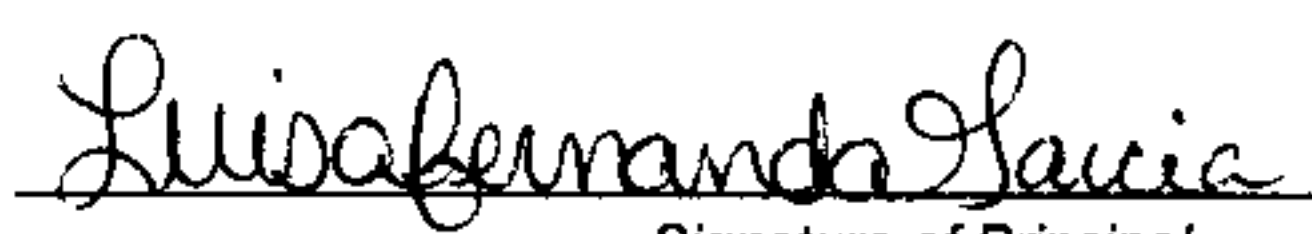

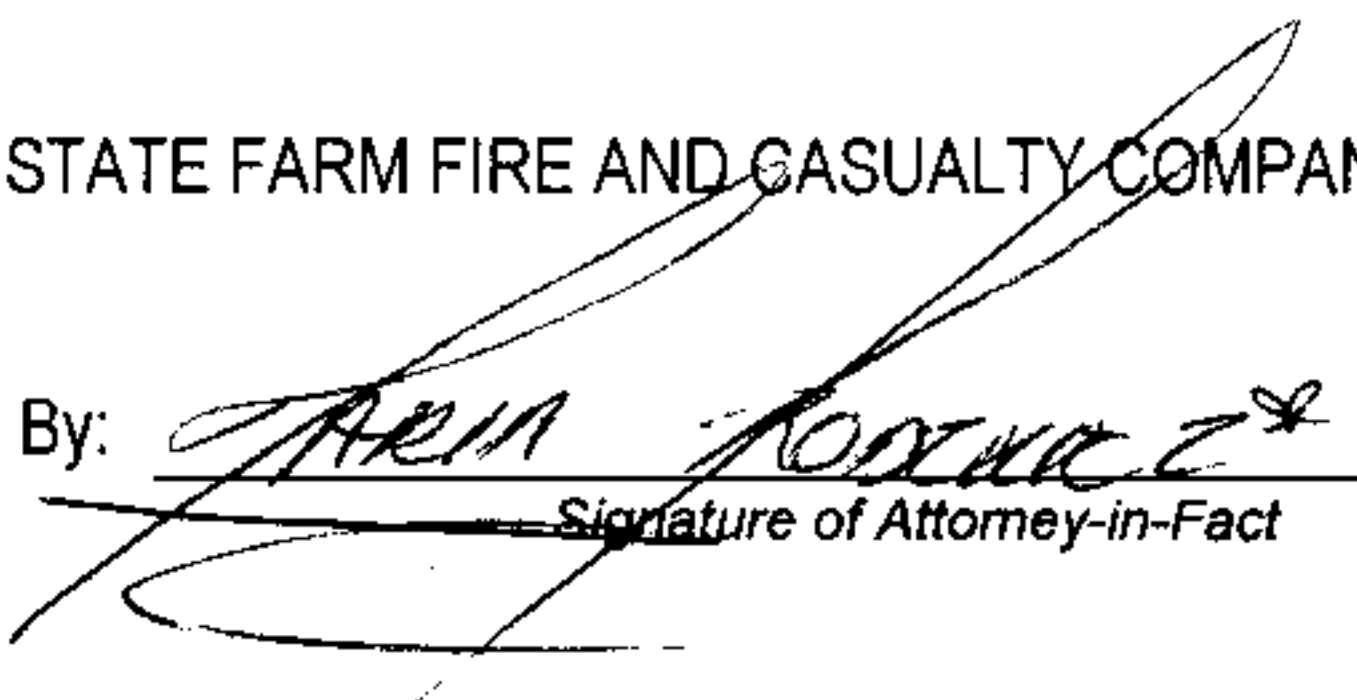

**POWER OF ATTORNEY
