**ARTICLES OF AMENDMENT
OF

COMES NOW, Hannah Home Shelby Auxiliary, Inc., by and through the undersigned President and Secretary, and according to the Alabama Non-Profit Corporation Act, does hereby adopt and amend its Restated Articles of Incorporation. These Articles of Amendment are intended to affect the following Article only and in no way is intended to supercede any other provision of its Restated Articles of Incorporation. The following amendment was duly adopted as required by law and is as follows:

ARTICLE I

The name of the corporation shall be changed from Hannah Home Shelby Auxiliary, Inc. to **Kings Home Shelby Auxiliary, Inc.**

This amendment was adopted by The Board of Directors on or about February 14, 2017 in accordance with Alabama law.

This Amended Articles of Incorporation is intended to amend the foregoing article only and in no way is intended to change, alter or amend its charitable purpose, internal revenue exemption, or any other article or matter whatsoever.

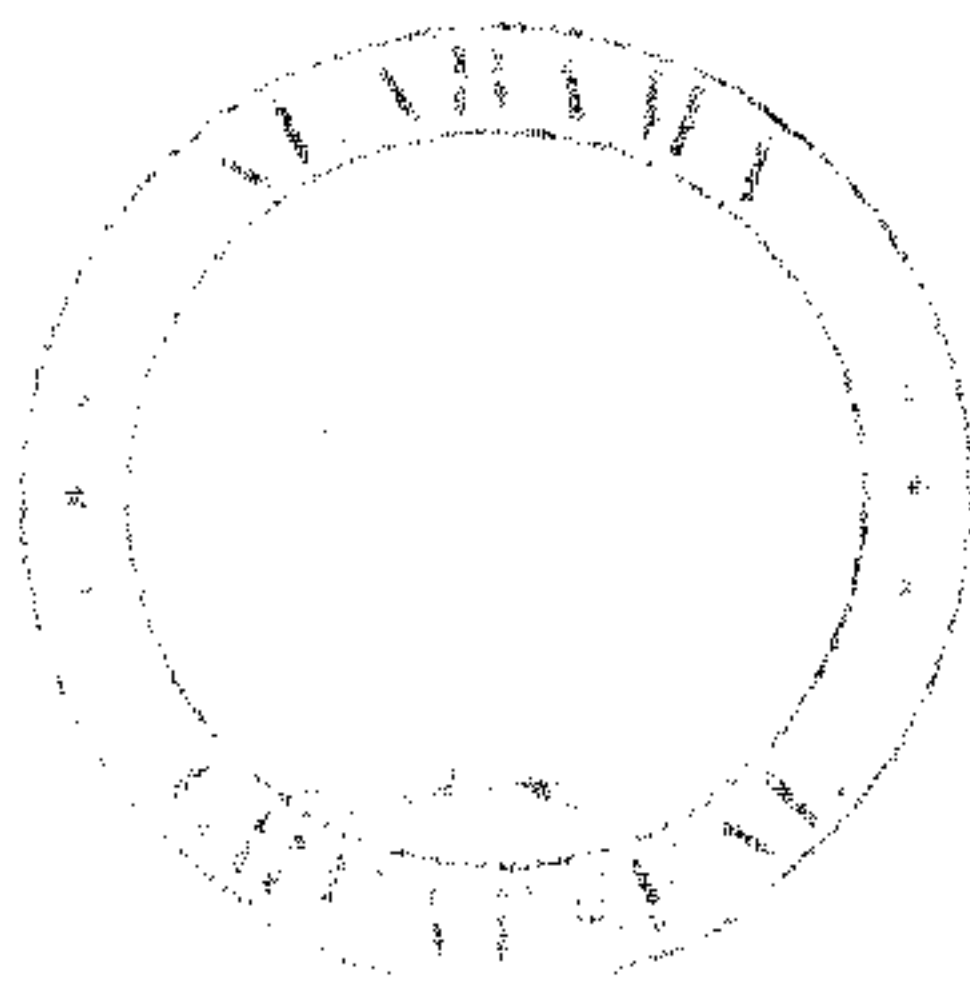
