KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of August, 2012, Chad Hamilton and Kristen Hamilton, husband and wife , executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for FirstBank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20120810000295320, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA, by instrument recorded in Instrument No. 20150120000020720, in the aforesaid Probate Office ("Transferee"); and

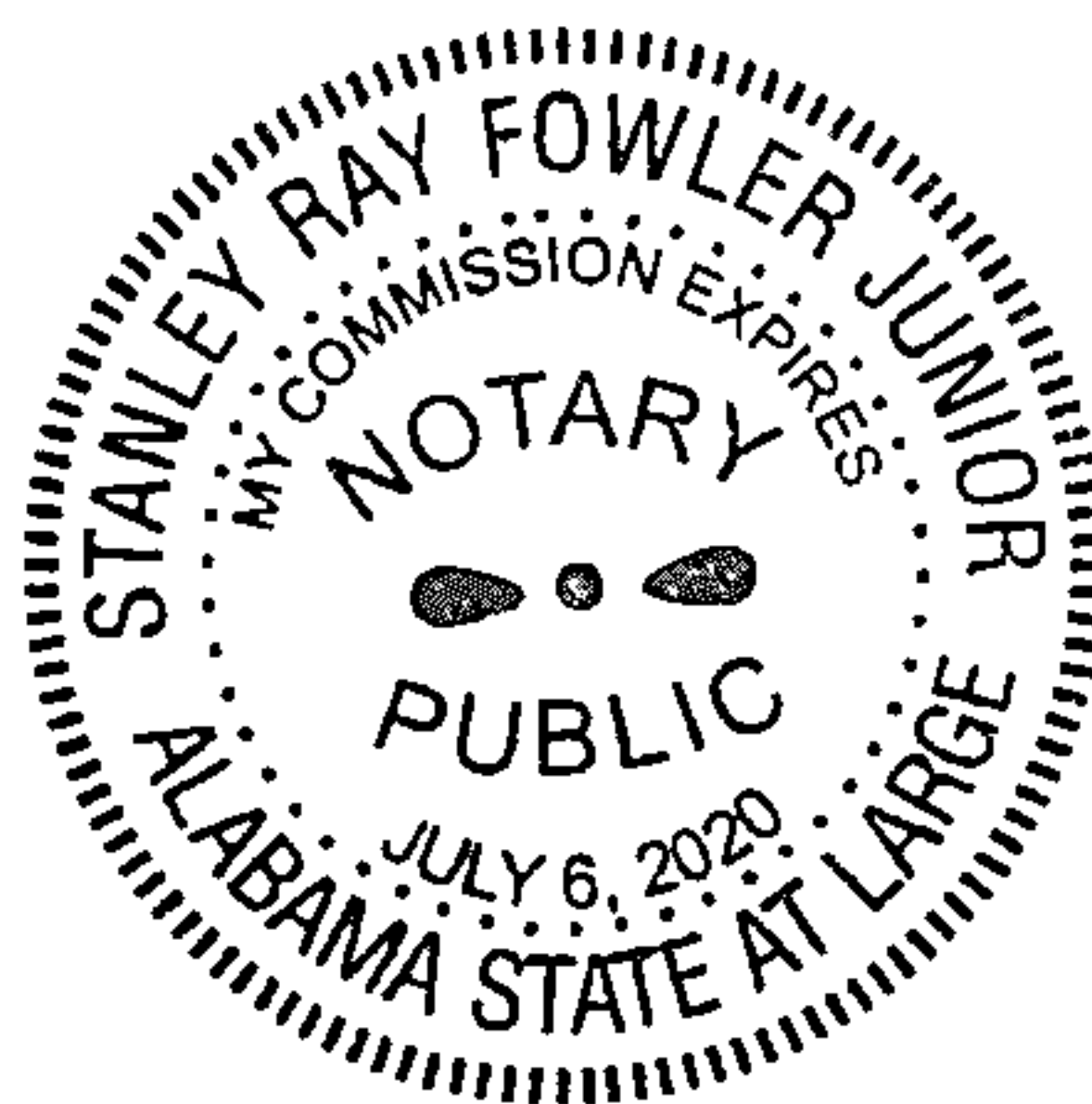
