

**CERTIFICATE OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
JIM HUBBARD & ASSOCIATES, LLC**
(Changing its name to Legacy Legal, LLC)

Pursuant to the Alabama Limited Liability Company Law as set forth in Chapter 1 and Chapter 5 of the Alabama Business and Nonprofit Entity Code, the undersigned hereby adopts the following amendment to its Articles of Organization:

ONE: The name of the company is Jim Hubbard & Associates, LLC (the "Company").

TWO: The Company is a limited liability company, whose Alabama Entity ID Number is 444 - 750.

THREE: The Company filed its Articles of Organization (Conversion from Delaware Corporation) with the Judge of Probate of Shelby County, Alabama, on March 16, 2010.

The name of the limited liability company is **Legacy Legal, LLC** (the "Company").



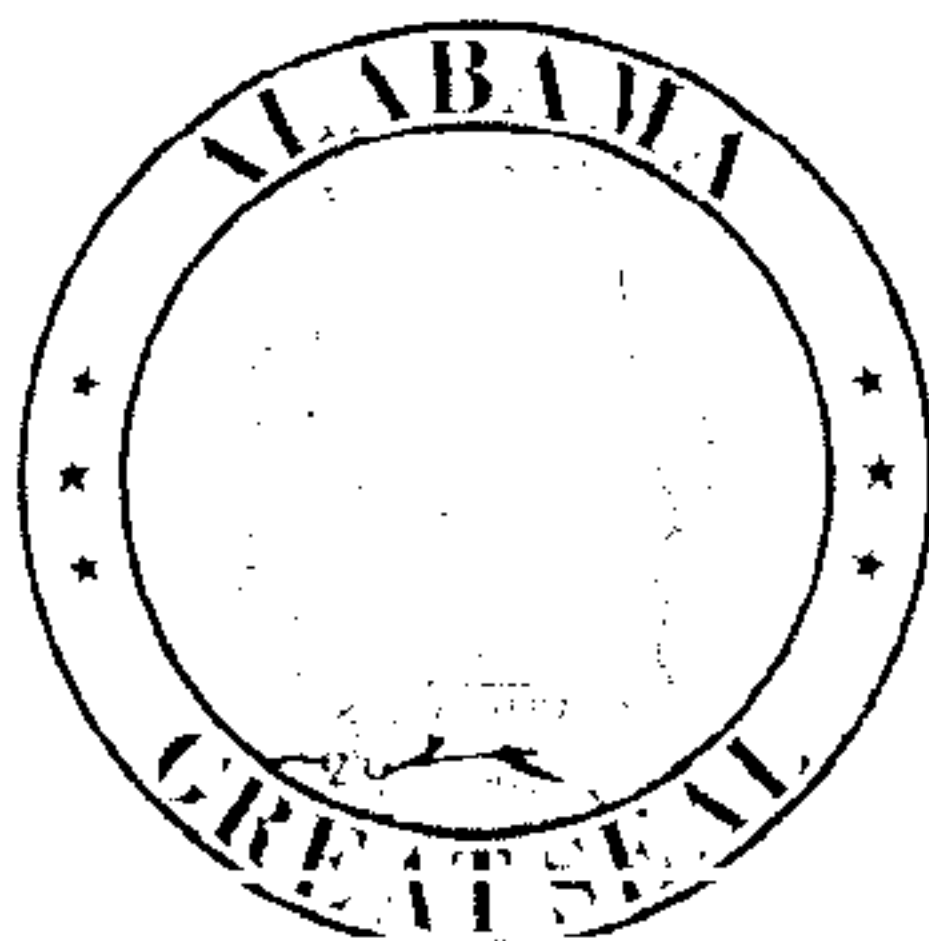
