WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One-hundred eighty-five thousand (\$185,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Howard Finley Jr., an unmarried man (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Allie Suzanne Moore and Jacob Todd Dickens (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 430, according to the Survey of Savannah Pointe, Sector V, Phase I, as recorded in Map Book 26, Page 50, in the Office of the Judge of Probate of Shelby County, Alabama.

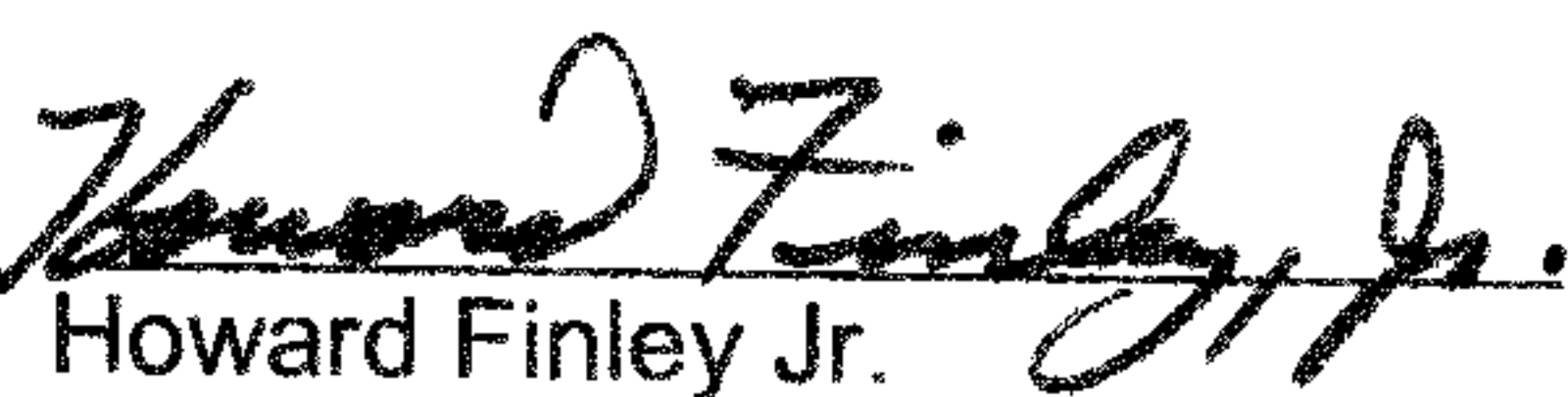
Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

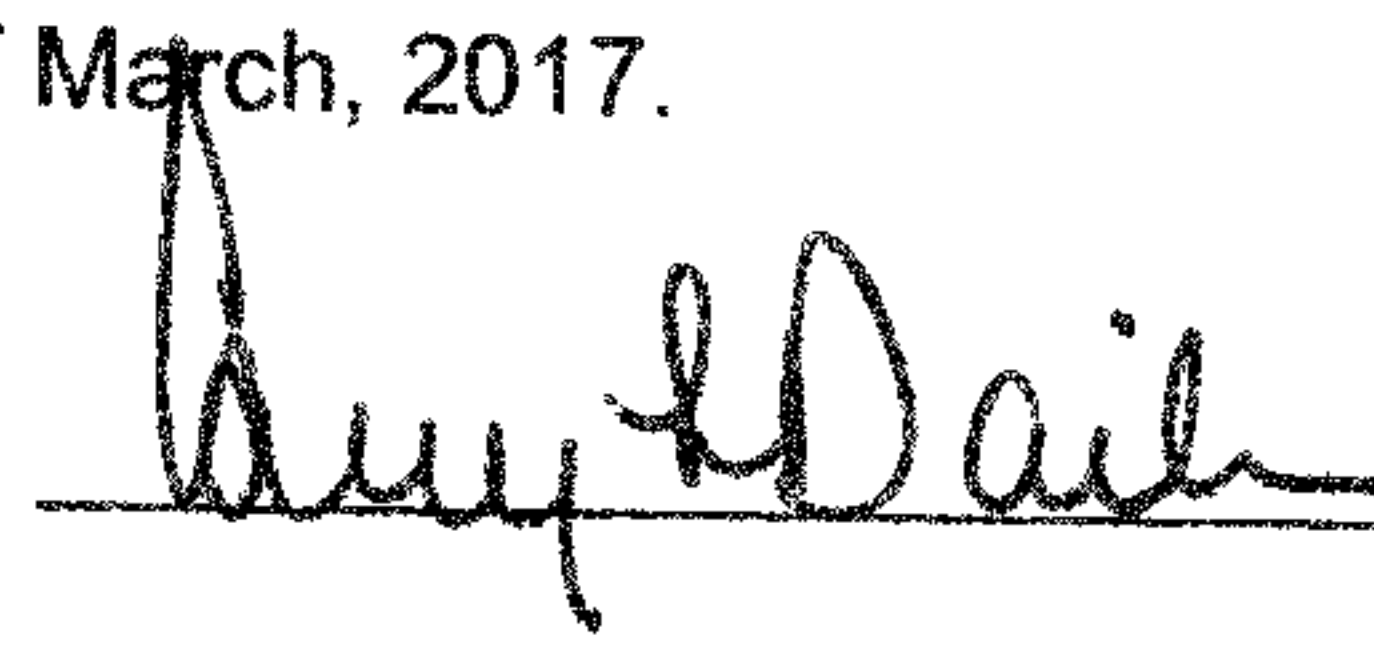

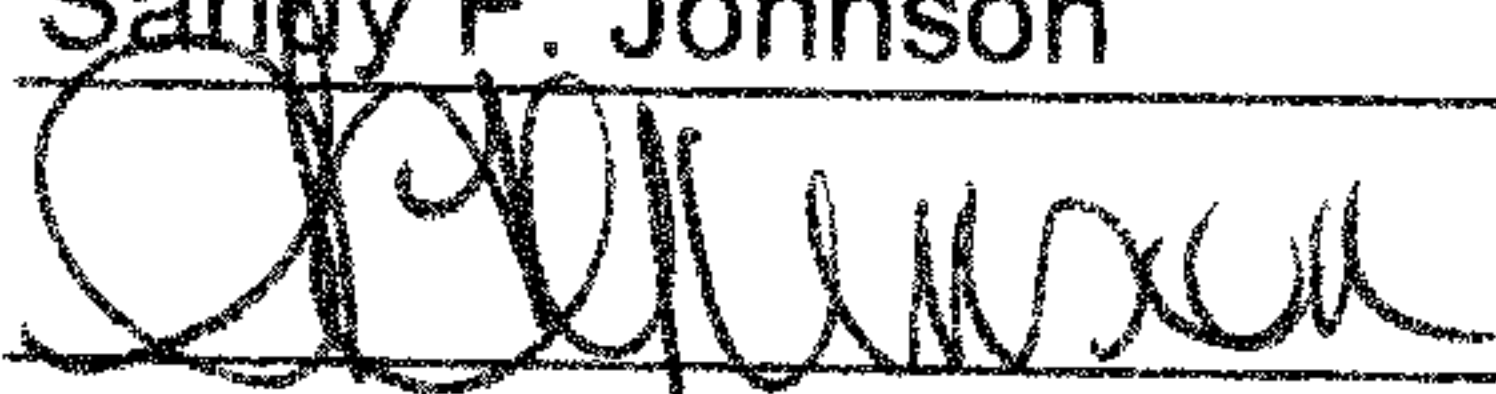
