KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 3rd day of July, 2014, Mary E. Stevens and James Stevens, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Platinum Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20140709000208250, said mortgage having subsequently been transferred and assigned to Pingora Loan Servicing, LLC, by instrument recorded in Instrument No. 20161117000423320, in the aforesaid Probate Office ("Transferee"); and

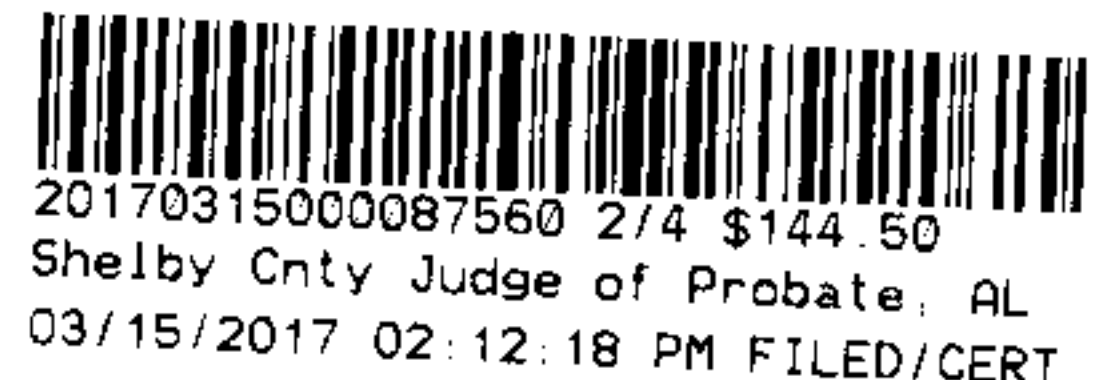

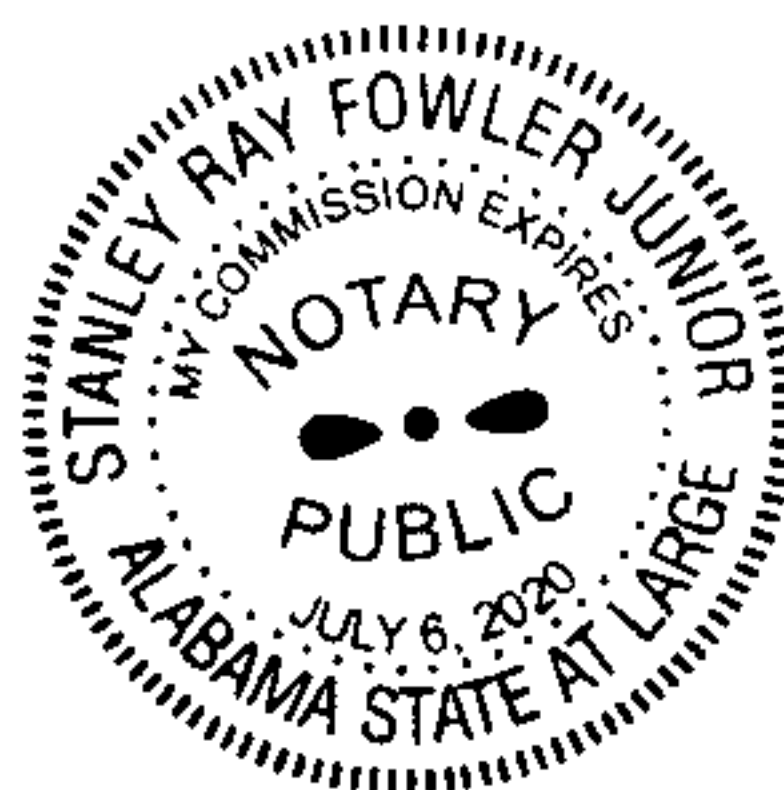
